ELEMENTARY STUDENT ATHLETE PARTICIPATION AGREEMENT

_____ has been selected to represent the school on the _____ Team. Please read and sign the following agreement with your child so that the expectations are well understood before the season begins.

AGREEMENT

As a valued member of the _____ Team, I recognize that I have two very different, yet important roles:

1. I am a student athlete.
2. I am a representative of my school

As an athlete:

1. I recognize that my role is based not only on my development as a player, but as a valued team member as well.
2. My desire to improve my game is the most important aspect of my role as a student athlete, and I realize that this involves coming to practice regularly and maintaining my school work.
3. I understand that any disciplinary action that is taken towards me for unbecoming behaviour will affect my place on this team. If I fall behind on homework and assignment completion, I may be removed from the team. This is a decision that will be done jointly by the coach and the principal.
4. I understand that my interests lie in the success of my team. I will behave at all times in a manner that is respectful to my fellow players and coach. Failure to do so could result in my removal from the team.
5. I understand that over the duration of the season, the coach will exercise Christian leadership in the achievement of individual and group goals. The coach will distribute playing time fairly which will be partially determined by my attendance and participation at practices, my team commitment, and my growth in skill development. Although an attempt will be made to allow all players to play an equal amount of time over the season, there may be variations from game-to-game.

As a representative of my school:

1. I will make decisions in light of gospel values with an informed moral conscience.
2. I will act in a manner that demonstrates the excellence that my school stands for.
3. I understand that when I am at another school, I will treat it as my own and any failure to do so could result in my removal from the team and further disciplinary action.
4. I will show respect to members of opposing teams, their coaches, and all referees.
5. I will refrain from using foul language at all times; as there is no place in athletics for poor sportsmanship.

I am here to learn, and I will perform and behave in a way that will achieve both the goals of the student athlete and the goals of my school's athletic program.
