Notice of Collection of Personal Information and Consent

Your personal information on this form and in all other communications related to apprenticeship and related programs will be used by MAESD to administer and finance Ontario's apprenticeship training program. MAESD will collect relevant personal information directly from you and indirectly from your school board, employer, sponsor, training institution, Employment Ontario (EO) service provider, the Ontario College of Trades (the College) and Canada for these purposes and may also disclose your personal information to these organizations. MAESD may use the services of other Ontario ministries, contractors and auditors to administer and finance apprenticeship training. You may be contacted to request your voluntary participation in surveys and public relations campaigns related to apprenticeship training.

Administration includes assessing and verifying your eligibility for apprenticeship, including your age, education and membership in the College; registering you as an apprentice and maintaining your file; providing financial assistance to you and your training institutions; working with you, your training institutions and your employers or sponsors to support your progress in and completion of workplace and classroom training; conducting examinations; issuing certificates of apprenticeship; evaluating, monitoring and auditing your progress and the activities of your employers, sponsors, trainer(s) and training institutions; reporting to Canada about the effectiveness of apprenticeship training as required under the Jobs Fund Agreement (JFA) between Canada and Ontario and the Labour Market Development Agreement (LMDA) between Canada and Ontario; enforcing your agreements with MAESD and the legislation set out below; enforcing the agreements between MAESD and your employer, sponsors and training institutions; detecting, monitoring and preventing fraud; and conducting policy analysis, evaluation and research related to all aspects of EO programs and services, including apprenticeship training.

Apprenticeship training is partly funded by Canada under Part II of the *Employment Insurance Act* (EIA). Under the LMDA, MAESD must collect your social insurance number to provide reports to Canada to allow it to monitor and assess the Employment Insurance Program under s. 3 of the EIA. Information you provide on education level, immigration status, Employment Insurance eligibility, Francophone status and prior participation in special apprenticeship programs helps design policies and programs to support apprenticeship completions, and better meet reporting requirements under the Canada-Ontario JFA.

MAESD will disclose your personal information, including your contact information and your registered training agreement(s), to the College under s. 80 of the Ontario College of Trades and Apprenticeship Act (OCTAA), 2009 when it is necessary for the College to carry out its responsibilities. MAESD may also disclose your personal information to:

- any of your employers or sponsors who need your apprenticeship training agreement for purposes of applying for the Apprenticeship Training Tax Credit under s. 89 of the *Taxation Act*, 2007, S.O. 2007, c. 11, Schedule. A;
- the Ministry of Labour under an agreement between the ministries to enforce workplace safety under the Occupational Health and Safety Act;
- any person employed in the administration of similar legislation in any Canadian province or territory under s. 79(8)(a) of the OCTAA, 2009; and
- to Statistics Canada, if required under s. 13 of the Statistics Act, R. S. 1985, c. &19, as amended.

OYAP Regional Level 1 – Program Information

The Ontario Youth Apprenticeship Program provides students with the opportunity to begin an apprenticeship while still in secondary school. Students participate in the Level 1 Program while in their final semester of Grade 12, however; the application process and interviews for coveted spots in the program begin in Grade 11.



Level 1 OYAP Programs are regular apprenticeships that include the first level of in-school training (Trade School) at either Fleming College in Peterborough or Durham College, Whitby Trade Centre. (The exception is Hairstyling and General Carpenter, Local 27 where students attend a Training Delivery Agent to obtain their first level of in-school training). In order to be a successful candidate for the OYAP Level 1 program, students should have achieved an average of 60% or greater at the college/university level in the Math, English and Technology course appropriate to their specific chosen trade. Students with Cooperative Education and/or work experience in the chosen area of interest will be given preference in the application process.

Applicants must be registered as 4 credit Cooperative Education students in Grade 12 and have their timetable adjusted to allow for the completion of all compulsory courses before their final semester in order to be eligible for graduation.

Students will earn 1 – 3 Dual Credits for the time spent at College in the Level 1 Program. These credits will count toward both their OSSD and their Apprenticeship Certification. (*Exception: Hairstylist and General Carpenter Local 27 are NOT dual credit programs.*) Cooperative Education credits are granted for time spent at the workplace, where students receive one credit for every 110 hours of work. In-school training hours do **not** count toward the total apprenticeship hours. However, hours spent in the workplace must be carefully documented as they would be a negotiable item between the Employer, the Training Consultant and the Apprentice; to be considered toward the total apprenticeship hour requirement. Students are encouraged to focus on obtaining the necessary skills required to complete their apprenticeship rather than on hours as each apprentice is provided with a Training Standards Document that is used to record their competencies and skill sets.

Students require approval of a Registered Training Agreement signed between the Sponsor/ Employer, the Apprentice and the MAESD (Ministry of Advanced Education and Skills Development) Consultant in order to attend the level 1 in-school training.

To officially be in the OYAP Level 1 Program involves; an accepted application, a successful interview and a Ministry approved Registered Training Agreement. Candidates are not officially in the program until all the components of the process are completed. If one of the requirements are not met, students may continue in a four credit Cooperative Education placement within the trade.

While in the Program, students attend the participating College (Durham or Fleming) for 1, 2 or 3 days a week (depending on the Trade). Transportation to the in-school training and work placement is the responsibility of the student and/or parent. However, in some circumstances OYAP students may be provided with bus transportation to the College. If this option is available, students are expected to use this mode of transportation. The remainder of the week is spent in a Cooperative Education workplace experience; students are not paid for this work. These work placements are arranged through the school's Cooperative Education Department. Cooperative Education teachers are responsible for setting up and monitoring suitable placements.

Additional Information:

- Costs associated with Level 1 (tuition, textbooks and some transportation costs) are covered by the school board. Course materials are provided by the College, but tools and safety equipment (i.e. safety boots) may be the students' responsibility.
- Students who have more than three unexcused absences from the College may be removed from the Program.
- Students are expected to treat their employers and co-workers with respect and adhere to all Cooperative Education guidelines.

Acceptance is ultimately dependent on a signed RTA:

- Student will be notified by the Cooperative Education teacher as to interview success.
- Student will receive a formal letter from the OYAP Coordinator as to their status(accepted, denied or placed on the waitlist).
- Student, parents/guardians and teachers will be asked to attend an information session prior to the start date of the program.
