1. <u>Report from the Director of Education.</u>

Mr. Michael Nasello, Director of Education, shared his report with the Board and highlighted that:

- Mr. Zachary Smith be recognized for his dedication and leadership in his role as the 2016-2017 Student Trustee and for promoting student voice throughout the system.
- Student Trustees for 2017-2018. Mr. Winston Steward, Sr. Student Trustee from St. Thomas Aquinas Catholic Secondary School and Ms. Calahndra Brake, Jr. Student Trustee from Holy Cross Catholic Secondary School, be welcomed as our 2017-2018 Trustees.
- The Board certified 12 schools with the Ontario EcoSchools for energy efficient sustainable school programs.
- The Ontario English Catholic Teachers' Association recognized the 2017 award winners of the Young Authors Award. Congratulations are extended to:
 - Nicholas Crowley, Claudia Flis, Cameron David Penhale, Meriel Sheridan.
- A letter of gratitude was received from the Multiple Sclerosis Foundation in recognition of all the schools in the Board in raising \$16,000 for the campaign.
- The Bat Rangers of St. Mother Teresa Catholic Elementary School in Courtice Video is raising awareness about White Nose Syndrome, which is killing millions of Brown Bats in North America. Grade 1 and 2 students, led by their teacher Michelle Rodriguez, worked together as part of a Deep Learning group at their school.

2. <u>Report from the Student Trustee(s).</u>

Mr. Zachary Smith, Student Trustee, shared his report with the Board and highlighted that:

- Elections for Student Cabinet members and Student Trustees by their peers took place. Student Cabinets in schools are elected each year to ensure the student voice is heard throughout the education system.
- The Student Council Liaison Committee will be working over the next year to collect best practices and then construct an outline that can be used to guide each of our schools in the election process.
- He joined Ms. Calahndra Brake, 2017-2018 Jr. Student Trustee as Board representatives at the Ontario Student Trustees' Association Annual General Meeting in Toronto. This offered a great opportunity for the Jr. Student Trustee to meet and network with her counterparts in Ontario. There will be a renewed focus on celebrating the strengths of Catholic students, and working together with the public board council to tackle common issues.

Mr. Smith, thanked the Board and all students for the opportunity to serve PVNCCDSB as the 2016-2017 Student Trustee.

C. Presentations:

1. Presentation to the Outgoing 2016-2017 Student Trustee, Mr. Zachary Smith.

Mrs. Michelle Griepsma, Board Chairperson, welcomed the parents and family of Mr. Zachary Smith. The Board and Mr. Michael Nasello, Director of Education, recognized Mr. Zachary Smith for faithfully supporting all student voices and thanked him his contributions to the Peterborough Victoria Northumberland and Clarington Catholic District School Board.

2. <u>Community Delegation Request re: Community Use of Schools – Peterborough Ladies</u> <u>Volleyball League.</u>

Ms. Alida Becker and Ms. Jen Leno, spokespersons for the Peterborough Ladies Volleyball League, discussed the handout presented to the Board outlining their concerns over their unsuccessful attempt to book space for the 2017-2018 season and requested the Board consider non-profit organizations be given priority over for-profit organizations in the booking of facilities through the Community Use of Schools program. The Board had an opportunity to ask questions and have discussion with the group.

Mrs. Michelle Griepsma, Board Chairperson requested:

- The review of alternative space in our system that might be available for this year.
- Confirmation that the online registration system was in working order on the application date in question.
- That Mr. Nasello, Director of Education, will respond to the delegation on the Board's behalf pertaining to the above requests.

The Board thanked the group attending and for bringing forward their concerns.

3. Technology Enabled Learning Plan (TELP) 2017-2020 Presentation.

Mrs. Laurie Corrigan, Superintendent of Learning/Innovation Technologies, Mrs. Marcy D'Alessandro, Student Achievement Consultant and Mr. Sean Heuchert, Manager of Information Technology, shared the details of the plan and answered questions.

This plan will be connected to the new Board Vision, Mission and Strategic Plan:

- Strategic Plan: LEARN
- Strategic Priority: Achieve excellence in instruction and assessment to enable all students to become reflective, self-directed, lifelong learners.
- Strategic Action: Encourage and facilitate responsible technology-enabled learning for all.

The areas of focus will be:

- Robotics and Coding
- Bring your own Device (BYOD)
- Security, Privacy and Parent Communication
- eLearning
- Catholic Learning Commons (CLC)

Next steps will focus on a communication plan and members of the Leveraging Technology Working Committee will monitor and provide ongoing reflections for the TELP.

The Board thanked the presenters for their work and presentation.

4. <u>Renewed Math Strategy Presentation.</u>

Mrs. Dawn Michie, Superintendent of Learning/K-12 Program, Dr. Sarah Taylor, Student Achievement Consultant and Mr. Mike Mooney, Student Achievement Consultant, presented the Renewed Math Strategy and answered questions.

The focus of the Math Theory of Action is to offer professional learning on implementing a balanced approach between building understanding and developing skills, which include problem solving, direct instruction, investigation, assessment and practice, then educators will be equipped to further develop students' critical thinking skills to solve meaningful problems. Areas looked at were Plan, Act, Observe and Reflect.

The Board thanked the group for their presentation and work.

5. Kindergarten Presentation.

Mrs. Dawn Michie, Superintendent of Learning/K-12 Program and Ms. Jen Wright, Student Achievement Consultant, made a presentation to the Board and answered questions.

The new organization of expectations will fall under four categories,

- 1. Demonstrating Literacy and Mathematics Behaviours
- 2. Self Regulation and Well-being
- 3. Problem Solving and Innovating
- 4. Belonging and Contributing *with teach, assess and report on Religious Education at PVNC

The presentation also reviewed:

- 2. Learning Environments
- 3. Assessment Pedagogical Documentation

- 4. Communication of Learning
- 5. Kindergarten Rounds

The Board thanked the group for their presentation and work.

Mr. Michael Nasello shared a report with the Board and answered questions.

Mr. Nasello presented presented the Draft Vision, Mission and Strategic Plan for 2017-2020. Mr. Nasello acknowledged all those who gave their time and ideas about who we can become in the years ahead.

Vision: Achieving Excellence in Catholic Education LEARN • LEAD • SERVE

Mission: To educate students in faith-filled, safe, inclusive Catholic learning communities by nurturing the mind, body and spirit of all.

Strategic Priorities: These will align with each of the imperatives of our Vision and are grounded in the Ontario Catholic Graduate Expectations.

- **LEARN:** Achieve excellence in instruction and assessment to enable all students to become reflective, self-directed, lifelong learners.
- **LEAD:** Foster critical thinking, creativity, collaboration, and communication, to enable all students to realize their God-given potential.
- **SERVE:** Inspire engagement and commitment to stewardship for creation to enable all students to become caring and responsible citizens.

For each of the Strategic Priorities there are nine strategic actions. Each set of actions has something we will encourage and facilitate, something we will continue and enhance, and something we will broaden and provide.

- Encourage and facilitate responsible technology-enabled learning for all
- Continue and enhance Assessment for Learning in every classroom
- Broaden and provide for differentiated support for all students and differentiated professional learning for all staff
- Encourage and facilitate deeper inquiry learning in every classroom
- Continue and enhance discernment of what it means to be Church in the world today in light of the Gospel and Catholic Social Teachings
- Broaden and provide for training and resources to support well-being for all students and staff
- Encourage and facilitate vibrant School/Parish/Home relationships
- Continue and enhance open transparent communication with partnerships
- Broaden and provide for local and global involvement in social justice, equity, Indigenous and environmental education

Purpose

The purpose of this report is to provide the Board of Trustees with a progress update relating to the Pupil Accommodation Review currently underway involving the Cobourg Catholic Elementary Schools. Staff provided a progress report to the Board of Trustees in June 2017 outlining the activities associated with the Cobourg Catholic Elementary Schools Review at that time. In June 2017, the Ministry of Education issued two Memoranda that have an impact on the Pupil Accommodation Review process. This report provides the Board of Trustees with an overview relating to the Ministry of Education memoranda and to confirm direction taken as recommended by staff.

Background

 At the March 28, 2017 meeting of the Peterborough Victoria Northumberland and Clarington Catholic District School Board, the Board of Trustees approved the Cobourg Catholic Elementary Schools Accommodation Review and specifically, the Initial Staff Report. Approval of the Initial Staff Report resulted in the formation of an Accommodation Review Committee (ARC) and the initiation of the review process. The schools involved in the review include Notre Dame, St. Joseph and St. Michael Catholic Elementary Schools. 2. On June 12, 2017 the Ministry of Education issued Memorandum 2017: B07 *Request for Capital Priorities Project Funding Submissions*. Contained within the memorandum, boards were advised:

"With this spring's announcements of School Consolidation Capital funding approvals, the ministry completes its commitment to invest \$750 million to support improved utilization of school space through the reduction of surplus capacity. The ministry will continue to support consolidation projects through its annual Capital Priorities program." And;

"School Consolidations: Projects that support the reduction of excess capacity in order to decrease operating and renewal costs and address renewal need backlogs. These projects may also provide other benefits such as improved program offerings, accessibility or energy efficiency. Projects linked to an accommodation review must have a final trustee decisions on the outcome of the pupil accommodation review by September 29, 2017."

As outlined in the memorandum capital project priorities must be submitted to the Ministry of Education by September 8, 2017.

3. On June 28, 2017 the Ministry of Education issued Memorandum 2017: B09 *Plan to Strengthen Rural and Northern Education*. Contained within the memorandum, boards were advised:

"The ministry will revise its Pupil Accommodation Review Guideline (PARG) to create a stronger, more collaborative process that better promotes the well-being of students and better recognizes the impact of school closures on rural and northern communities.

The aim of the revised PARG is to promote inclusion of community impact alongside the focus on student achievement and well-being. The ministry will achieve this by:

- Considering amendments to introduce: longer minimum timelines; more recommended pupil accommodation options; clear roles for school board trustees and municipal governments; and an increased student voice.
- Providing a new toolkit and resources for school boards to standardize and validate data.
- Providing templates for community partners to engage school boards.

In early fall 2017 the ministry will engage with key stakeholders (including partner ministries, school board and municipal sector representatives) to seek input on a revised version of its PARG. Once the revised PARG and supporting resources have been released, school boards will revise their PAR policies and consult on these revised PAR policies for several months before approving them.

School boards will not start new PARs until the revised PARG is complete, unless PARs are required to support a joint-use school initiative between two school boards. For PARs that are already underway, a board may either continue with the PAR process initiated under its existing PAR policy or wait until the ministry releases the revised PARG to continue. School boards will not have to reconsider past decisions"

Discussion

Both Ministry of Education memoranda have an impact on the Cobourg Catholic Schools Accommodation Review.

The *Request for Capital Priorities Project Funding Submissions* memorandum 2017 B:07 states that funding for consolidated schools will be ending and that future accommodation review decisions will follow the annual capital submissions program. Further, all current accommodation review requests for capital funding must contained a board approved motion by September 29, 2017. As the Cobourg ARC process is halfway through with the anticipated final decision planned for February 27, 2018, staff submitted the capital request for a new replacement school, as outlined in the Initial Staff Report, in the September 8, 2017 submission. Staff highlighted that the submission is subject to the final staff report recommendation and Board of Trustees decision. This approach ensures that the project remains active with the Ministry of Education and is a placeholder in the capital priorities process subject to the outcome of the ARC process.

Further, as outlined in the Ministry of Education memorandum 2017: B09, *Plan to Strengthen Rural and Northern Education*, Pupil Accommodation Reviews (PAR) Guidelines are under-review and that boards with current PAR's may continue with the process under their current policy or wait until the Ministry issues the revised PARG. Staff have reviewed the memorandum and have determined that the intent of the proposed revisions to the PARG, based on Northern, Rural and Remote education, does not impact the urban - Town of Cobourg schools and is recommending that the Cobourg Catholic Schools Accommodation Review continue.

(5) When the term of a member of the audit committee expires, he or she continues to be a member until a successor is appointed or the member is reappointed.


