B. Recommended Actions/Presentations:

1. Remarks: Vice Chairperson, Clare Paterson

Clare Paterson welcomed the committee and guests, as well she gave a brief overview of her time on the committee since joining in 2010.

2. Remarks: Superintendent of Learning/Special Education Services, Jeannie Armstrong

Superintendent Armstrong thanked Clare Paterson for chairing the meeting. Addendums to the agenda under the category of correspondence, includes a letter to the Ministry regarding Special Incidence Portion funding. The letter from PVNCCDSB's SEAC was requested by and forwarded to the Ontario Catholic School Trustees Association.

Principal professional development occurred March 22, from our special education team and mental health and well-being teams. Topics presented included The Third Path, Individual Education Plans (IEPs), and Special Equipment Amount funding (SEA). Upcoming professional development will include Learning for Living (LFL) and Learning Life Skills (LLS) teachers, vice principals and special education curriculum chairs.

OECTA supports the implementation of diagnostic assessment tools including the Phonological Awareness Screening Tool (PAST) and the Quick Phonics Screener (QPS). These tools will be administered by special education resource teachers to help determine Tier 2 and Tier 3 reading interventions for students.

The department is beginning the planning and budgeting process for next year, although we are still awaiting information from the Ministry in regards to funding. More information will be forthcoming as the budget is determined and will be presented by Superintendent Heuchert and Chief Financial Officer Teri Smith at the May meeting.

3. Remarks: Trustee Kathleen Tanguay

Trustee Tanguay shared that at the last Board meeting there was a lot of discussion in regards to St. Elizabeth Catholic Elementary School Bowmanville, which is currently sitting at 197% capacity. Finding a solution for the capacity issue has been challenging, with the potential to move some students in higher grades to St. Stephen Catholic Secondary School or possibly a new school being built. If these students were moved to the secondary school, special education considerations for support would need to be determined.

C. Presentations/Discussion Items:

1. Durham Community Transition Evening - Erin Bibby, CASA Teacher, Holy Trinity CSS

Erin Bibby presented on the Durham Community Transition evening that was hosted by the Durham District School Board she attended with Autism Home Base, an organization she volunteers with. The annual event offered information to families on transitions from approximately 50 community organizations. The event was easy to navigate as organizations were identified by function through varying table cloth colours. The event was held at the Durham District School Board office, offering a sensory friendly atmosphere with no music, dim lights, and quiet spaces. DDSB also offers information on the event on their website. The event also offered the opportunity to build personal connections.

It was explained how a similar event may be beneficial for PVNCCSDB families as students age out of school programming; even if offered regionally. It would also be a good opportunity for educators to attend to gather information for transition meetings.

From the Presentation:

The committee discussed the presentation and how this may be a beneficial event for PVNCCDSB to host in the future. There was discussion in collaborating with the public board and Durham to maximize participation from organizations with the possibility of servicing multiple exceptionalities.

2. De-Streaming to Support Special Education Students - Sandra Connolly, Learning Consultant and Sheila Piggott, Superintendent of Learning

Superintendent Sheila Piggott gave an overview of the previous secondary pathways and the research supporting destreaming. Previously, pathways were decided for workplace, college or university depending on what was projected for the student. Research has shown that marginalized and special education students were transitioned into the workplace or applied pathways instead of academic streams. Ontario was the only province that transitioned pathways at grade 9, other provinces did so at a higher grade (usually 10 or 11).

The rationale for destreaming is to promote equitable access to curricular pathways. Open courses, which are destreamed courses already exist. These courses include physical education, art, business and religion. Data suggests that in grade 9 math only 8-10% of students in the academic pathway had an IEP, whereas 48% of students in applied courses had an IEP. In grade 10 English, over 50% of the students in applied courses had an IEP, whereas only 10-13% of students in the academic pathway had an IEP.

The classrooms' environment and educators will need to adapt to support destreaming using such tools as universal design for learning, building thinking classrooms, assessment for learning and culturally relevant and responsive pedagogy. PVNCCDSB has also completed a grade 9 destreaming writing project, which involved having schools write lessons individually and then providing sharing and networking opportunities between schools. It is important in this process of destreaming to seek student voice.

From the Presentation:

The committee discussed the presentation and how challenging it is to choose a pathway at such a young age. They liked how this will help support the students with learning challenges and be more equitable for all students. The group discussed the potential for destreaming grade 10, which at this point won't happen for the upcoming school year but could occur in the future. The committee discussed how the timing of modifications for students can also affect pathways.
