 SEPSAW - Special Education Plan for Student Achievement and Well-being - Karen Spenceley, Vice Principal of Special Education Services Board Strategic Priorities

Karen Spenceley presented on the Strategic Priorities 2021-2025. She discussed the three areas of focus: Being Creative- we will continue with supporting schools in the implementation of Universal Design for Learning (UDL) strategies to reduce barriers for students. Clinical staff are reinforcing universal learning strategies, relationship based learning and tiered intervention through consultation and modeling. Being Well - we will focus on students' strengths by using affirming language, navigating barriers and bias and promoting and honouring a culture of learning diversity. Being Community - we will continue to support a relationship-based approach where intersectionality is considered when problem solving

2. Summer Learning - Jennifer Angelo, Mental Health Lead

Jennifer Angelo presented on the Summer Learning Programs that were offered in 2023. There was a Strong Kids "Camp" which included 4 day sessions focusing on skill development and positive coping. Programs were located at four different sites and had various activities offered to the students. There was also a Summer Transitions Program offered to help with transitions from virtual school to in-person and included skill development sessions with home school visits.
