7. Business Arising Out of the Minutes.

There was discussion about the difficulties experienced by trustees with the connectivity to the virtual meetings held jointly on November 29, 2021 with Kawartha Pine Ridge District School Board. It was noted that some trustees were not able to effectively take part in the meeting and a suggestion that technology for meetings be tested ahead of time for virtual meetings.

Chairperson Braden Leal and Vice-chairperson Kevin MacKenzie were congratulated on their new positions of leadership with the Board of Trustees.

B. Reports from the Office of the Director and Student Trustees:

1. Report from the Director of Education.

Joan Carragher gave the Director's Report, which included the following points:

- Congratulated the Board of Trustees as they begin a new year with the leadership of Board Chairperson, Braden Leal and Board Vice-chairperson, Kevin MacKenzie.
- Noted the passing of former PVNCCDSB trustee, Mary Amyotte, who was the first woman trustee to serve the board and offered sympathy and prayers of comfort to her family.
- Reviewed the list of active cases in PVNCCDSB schools, which have been kept quite low, and only one school is in a declared outbreak at the present time.
- Rapid Antigen Tests, which have been provided by the Ministry of Education, were distributed to all schools and will be sent home with each student this week. Each student will receive five tests for use over the holiday break. In addition, a number of PCR tests are available at each school for use at the direction of public health, if needed.
- Secondary schools will return to a full semester model of four courses for the second half of the year, beginning on February 2, 2022.

- The Student Council Liaison Committee Student Leadership Retreat took place on December 6. The theme of the virtual session was 'Voices that Accompany: Being Creative'.
- Congratulations were extended to each of the Principals and Vice-principals on their efforts in working with school staff to keep children safe through these challenging times.
- The Hon. David Piccini, Minister of the Environment and Sam Oosteroff, Parliamentary Assistant to the Minister of Education visited St. Francis of Assisi Catholic Elementary School on December 14. Thanks were extended to Teacher Adele Cronin and her Grade 4 class, Principal Stephen Smith, Superintendent of Schools, Jeannie Armstrong and Trustee Linda Ainsworth for hosting these special guests.
- Wished everyone a Merry Christmas with all of God's blessings.

Following her report, Joan Carragher invited questions and comments from the trustees.

2. Report from the Student Trustee, Siobhan Marie.

Student Trustee Siobhan Marie gave the Student Trustee report which included the following highlights:

- Student-led initiatives in schools during Safe and Caring Schools Week included a collection of 3,400 pairs of shoes at Holy Trinity Catholic Secondary School for the Soles4Souls Organization and a fundraising effort at St. Peter Catholic Secondary School that resulted in \$6,200 collected for the Peterborough Regional Health Centre in memory of student Raj Shahe.
- Christmas spirit week activities have taken place throughout all secondary schools including gingerbread house decorating, food drives and other fundraising for organizations such as St. Vincent de Paul Society.
- The Student Council Liaison Committee hosted a student leadership retreat for student council members from all PVNCCDSB secondary schools. The retreat series will have three sessions that will follow the three pillars of the strategic priorities. The theme of the first retreat was titled 'Voices that Accompany: Being Creative'. The guest speaker was Mr. Paul Crough, teacher from St. Peter Catholic Secondary School who talked about his own experiences, inspirations and ways of being creative.
- Kevin MacKenzie was welcomed to the Student Council Liaison Committee as the new Board Vice-chairperson.
- Gratitude was expressed for the ongoing support to all students from educators and those who support the SCLC committee and student councils in schools.
- Extended best wishes for the relaxing and very Merry Christmas.

Siobhan Marie invited questions and comments at the conclusion of her report.

3. Report from the Manager of Communications.

The Manager of Communications, Galen Eagle shared system highlights from all areas of the board which included the following highlights:

- The annual Christmas concert celebrated the spirit of the season at St. Mary Catholic Secondary School. The event was held this week outdoors in a modified COVID-19 format.
- The Board surpassed its United Way fundraising goal this year raising more than \$68,000 board-wide through payroll deduction and special events that took place throughout the board.
- The board's Christmas card features student artwork this year. Zoey Levy, a Gr 12 student from Holy Trinity Catholic Secondary School had her creation depicting the genealogy of Jesus Christ chosen from hundreds of entries.
- 3,400 pairs of shoes were collected at Holy Trinity Catholic Secondary School to support 'Soles4Souls' a not-for-profit global organization committed to fighting poverty during Safe and Caring Schools Week.
- Director's Annual Report for 2020-2021 has been released and is available on the Board website.
- Dr. Niigaan Sinclair visited our board to continue his work with our community on Truth and Reconciliation. He was able to connect virtually and engage with students from across the board in Grades 5-12. He met with administrators to speak about the importance of Truth and Reconciliation in the hallways of our schools.

At the conclusion of his report, Galen Eagle invited questions and comments from the trustees.

Superintendent of Learning Sheila Piggott introduced Learning Consultant Sarah Taylor and Annie Corkery, Teacher at St. Anne Catholic Elementary School who gave a presentation on the initiatives being undertaken with respect to Protecting the Environment, one of the eight priorities named in the Board's Strategic Plan.

The powerpoint presentation outlined the journey of this priority over the last two years

including the work that continued from the student presentation to the Board in February, 2020. The work has continued to the development of an environmental program to care for the earth that will be available to all classrooms engaging students to integrate the Board's strategic pillars of Being Well, Being Creative and Being Community.

Following the report, the presenters answered questions from the trustees.

2. Director's Annual Report, 2020-2021.

The Director of Education, Joan Carragher gave a presentation on the 2020-2021 Director's Annual Report which documents the progress of the board in relation to the Board's strategic goals. The review included evidence in all eight strategic priorities.

Joan Carragher, Director of Education, thanked the communications department for their support of the completion of this report. At the conclusion of the presentation, the Director invited and answered questions from the trustees.

Subject: School Year Calendar

Recommended Action(s): Approval of the Draft 2022-2023 School Year Calendars – Option A, as submitted

BACKGROUND:

The Google survey was used to collect feedback on the proposed two options for the 2022-2023 school year calendars. The survey link was set up on the Board’s external web site from November 29, 2021 through to December 17, 2021. Advisement that the survey was available was sent by email to all PVNC Staff, Trustees and Catholic School Council Reps. The same information was sent to all school principals, vice-principals and secretaries for use in print (i.e. school newsletters) and electronic communications (i.e. Twitter, Facebook) to encourage parent participation in the survey. School principals were requested to have the draft school year calendar on their School Council meeting agenda. The Communications Department included a ‘banner’ on the home page for the PVNC web site which included a link to the Calendar options being considered and the survey.

There were 2035 responses to the school year calendar survey. Parents/guardians and students made up 63.1% of the responses. Of those who responded to the survey, 69.9% selected Option A as their preference. With Option A, the Christmas break will be from December 26 – January 6 and the Friday before the March break will be a Board holiday.
