The Board Chairperson Kevin MacKenzie called the meeting to order at 6:30 p.m. and welcomed guests and media who had joined online. B. Reports from the Office of the Director and Student Trustees:

1. Report from the Director of Education.

Joan Carragher, presented the Report from the Director of Education, which included the following points:

- Mass of Remembrance for PVNC community members was held on November 23rd at St. Peter's Cathedral. The Mass was celebrated by Bishop Daniel Miehm and was followed by a reception held at Bishop Doyle Hall. Thank you to Trustee Jenny Leahy for attending and representing the trustees.
- On November 24 & 25 attended a meeting of the English Catholic Council of Ontario Directors of Education (ECCODE). This was the first face to face meeting of this provincial council since 2020. Bishop Miehm was in attendance at this meeting as the newly elected Chair of the Education Commission.

- Attended the Student Council Liaison Committee's retreat on December 2nd held at St. Peter Catholic Secondary School. The retreat was student-led and attended by student leaders from our secondary schools. The activities focused on the theme "Voices that Empower."
- Selected entries from the Christmas Artwork contest were displayed, including the overall winning entry from St. Catherine.
- Joy is palpable in our schools during the season of Advent as students prepare for the holiday and into the celebration of the birth of our Lord Jesus Christ.
- Best wishes for a blessed Christmas and a wonderful holiday season with peace and happiness into 2023.

Joan Carragher invited questions and comments from the trustees at the conclusion of her report.

2. Report from the Student Trustees.

Senior Student Trustee, Siobhan Marie and Junior Student Trustee, Madelyn Gaskell, gave the Student Trustee report which included the following highlights:

- Students are excited that only three days remain until Christmas break.
- Schools throughout the board have been celebrating advent with Mass and Grade 9 retreats.
- Extra-curricular Sports have resumed in full capacity with many students taking part in school teams, intramurals, and tournaments.
- Many charitable actions are underway in many schools including at St. Peter Catholic Secondary School where the Saints Action team has raised awareness about homelessness.
- St. Thomas Aquinas Catholic Secondary School has raised funds for their "Be An Angel" program to assist families in need.
- A food drive was held at St. Mary Catholic Secondary School to assist those in the community experiencing food insecurity.
- The Student Council Liaison Committee (SCLC) celebrated "Voices that Empower" the first in-person student leadership retreat since 2019, hosted on December 2nd at St. Peter Catholic Secondary School. Guest speakers, Asante Haughton and Benjamin delivered powerful messages of empowerment to the students.
- Gratitude was extended to those who were able to attend and to everyone who
 helped to organize the event noting the perseverance of the SCLC committee
 who greatly assisted to make the day a success.

Siobhan Marie and Madelyn Gaskell invited questions and comments at the conclusion

of their report.

3. Report from the Communications Department.

Galen Eagle, Manager of Communications shared the system achievements from all areas of the board which included the following highlights and initiatives from the PVNC Inspires newsletter:

- The Student Council Liaison Committee Retreat for student council members from all six secondary schools were able to gather in person for the first inperson retreat since 2019. A video highlighting the day's activities was viewed.
- More than \$56,000 has been raised during the 2022 United Way Campaign. In spite of recent inflation, labour disruption at the beginning of the campaign, PVNCCDSB has been able to raise a significant amount of funds for the United Way in all regions of our board.
- The top entries from the 2022 Director's Christmas Art competition were reviewed. The entry submitted by Grade 7 student, Maia Maret, from St. Catherine Catholic Elementary School was chosen to be the artwork featured on the Director's Christmas Card this year.
- Immaculate Conception Catholic Elementary School hosted Tom Wilson,
 Mohawk artist/musician, who shared learning experiences with students to further their knowledge and engagement in Truth and Reconciliation.
- The introduction of #PVNCInspires in the Classroom, a new feature of the monthly newsletter that will highlight stories of exceptional events happening in our schools throughout the board.
- St. Peter Catholic Secondary School hosted a Special Olympics qualifying basketball tournament. Teams that advanced from the tournament participate in a provincial championship in the spring.
- Holy Trinity Catholic Secondary School held a cake auction and raised over \$1,000 for local charities.
- The Everyday Hero staff recognition program is continuing and there are six deserving, caring, and uplifting staff members recently nominated and recognized by their peers.
