1. Report from the Director of Education.

Joan Carragher, Director of Education, presented the Report from the Director of Education, which included the following points:

- St. Alphonsus Catholic Elementary hosted a citizenship ceremony on May 25th that included local dignitaries.
- St. Catherine Catholic Elementary hosted the annual Catholic Parent Engagement Committee guest speaker event on June 13th that featured guest speaker Patrick Rivard whose topic was 'The Post-Pandemic Effect – Understanding and Managing the Social, Emotional and Traumatic Impacts of a World-wide Pandemic.

Board Chairperson, Kevin MacKenzie made a gift presentation to Student Trustee, Siobhan Marie who will be graduating this week. Kevin MacKenzie expressed his gratitude and extended best wishes to Siobhan as she leaves to pursue post-secondary education at Queen's University.

4. Report from the Student Trustees.

Senior Student Trustee, Siobhan Marie and Junior Student Trustee, Madelyn Gaskell gave the Student Trustee report which included the following highlights:

- Over the last year the secondary schools have seen a surge in involvement in their school community activities.
- Have seen commitment to important causes and events such as expression of solidarity for Truth and Reconciliation.
- Link leaders in all schools welcomed students through events organized with the sense of belonging and camaraderie among the Grade 9 students.
- Elections for positions on student councils were held and the resulting leadership shaped the planned activities for the year with the interest of the students in mind.
- Terry Fox fundraising events remain a focus and St. Peter Catholic Secondary School upheld their tradition of being a top fundraiser by presenting \$27,000 to the Terry Fox Foundation.
- The return of sports and extra-curriculars to pre-pandemic engagement levels and has ignited school spirit and all the benefits of physical activity.
- Catholic Student Leadership Awards were a highlight of Catholic Education Week, a week of celebration of our faith-based learning.
- Excited to welcome a new cohort of students who will begin Grade 9 in the fall.
- Thanks to all who contribute to the health and well being of students in inclusive learning environments and we look forward to celebrating achievements and our future.
- Madelyn Gaskell thanked Siobhan Marie for her service as a student trustee and for her mentoring and truly making an impact on the board.

5. Report from the Communications Department.

Galen Eagle, Manager of Communications shared the system achievements from all areas of the board which included the following highlights and initiatives from the PVNC Inspires newsletter:

- For the month of June, St. Luke Catholic Church in Downeyville has reestablished a noon-time ritual of sounding the church bell to call parishioners and residents to pray the Angelis for the St. Luke Catholic Elementary School graduating students.
- Siobhan Marie, student at St. Thomas Aquinas Catholic Secondary School and Senior Student Trustee for PVNCCDSB has been awarded a number of prestigious scholarships and awards, including the Terry Fox Foundation Humanitarian Award and the TD Scholarship for Community Leadership.
- Clarington siblings, Sophia and Simon Webster, from the PVNC Catholic virtual school community have been featured in movies and television productions.
- Amarichi Okpalugo, Grade 12 student at St. Stephen Catholic Secondary School
 has been recognized by the Ontario English Catholic Teachers' Association
 (OECTA) Young Authors Award for her poem entitled: 'The Narrative'.
- As it has in recent years, the Student Council at St. Thomas Aquinas Catholic Secondary School raised funds in support of the Ross Memorial Hospital's Mental Health Unit during their recent "Week of Wellness". Their contribution was recognized by the hospital with a donor plaque to commemorate their cumulative gift of over \$5,000.

At the conclusion of the report, Galen Eagle invited questions and comments from the trustees.

6. Chairperson's Report.

Kevin MacKenzie delivered his Chairperson's Report and recognized that this meeting marked the final board meeting for Joan Carragher, Director of Education. Kevin MacKenzie thanked Joan for over 30 years of service in Catholic Education and for her dedication and leadership at PVNCCDSB in her roles as a Teacher, Vice-principal, Principal, Superintendent and Director of Education. A video presentation with messages from former trustees was viewed. Joan Carragher thanked the trustees, past and present for their kind words and well wishes.

C. Presentations:

1. <u>Providing Excellence in Teaching and Learning: Student Success Programs – Summer Learning Programs, Continuing Education, and Experiential Learning.</u>

Superintendent of Learning, Jonathan Di Ianni and Lisa Cole, Principal of Continuing, Adult, and Experiential Learning gave a presentation about various student success programs which are transpiring at PVNCCDSB. An overview of the Ontario Youth Apprenticeship Program was given highlighting the types of apprenticeship programs offered and the involvement of partner colleges. It was noted that 1,000 students are registered for summer learning programs this year: eLearning, credit recovery summer school, reach ahead summer school, including some French Immersion courses, COOP and OYAP programs. Special education supports will be in place in summer programs for students participating who require them.

In addition, there are summer transition programs for Grade 8 students who are transitioning to secondary school, "Taste of the Trades" programs for female students, a canoe build program with an Indigenous educator, and the "Focus on Youth" program will engage at-risk youth students from all geographical areas of the board.

At the conclusion, the presenters invited and answered questions from the trustees.

D. Programs and Services:

1. <u>St. Elizabeth Catholic Elementary School Program Update: Grade Eight Transition to St. Elizabeth Catholic Elementary School Annex.</u>

Julie Selby, Superintendent of Learning gave a presentation to update the trustees on the physical space and program that the Grade 8 students will experience next year at the St. Elizabeth Elementary School Annex located at St. Stephen Catholic Secondary School. St. Elizabeth Catholic Elementary School on Longworth Avenue will be connected with the annex site for the purpose of communicating directly into the classroom from the office. The school administration, Superintendent and board office personnel have reviewed the health and safety and emergency response procedures that will be followed, as well as transportation procedures, arrival and departure procedures, programming, technology, equipment, and access to physical education spaces and learning commons spaces at St. Stephen. Preparations are underway to get the space ready for the students. Leadership opportunities, physical spaces and decoration will be considered to encourage and define a space with a sense of community for the students.

Julie Selby answered questions from the trustees at the end of the presentation.

E. Business, Finance and Governance:

1. Ontario Catholic School Trustees Association (OCSTA) Open Session Report.

The Board Chairperson, Kevin MacKenzie, reported that all information from the OCSTA has been shared with the trustees this month and that he will continue to forward information as it comes in over the summer months. The OCSTA Fall Regional meeting was announced as taking place on September 20, 2023, and will be hosted at the Catholic Education Centre at PVNCCDSB.

Throughout the history of Catholic education in Ontario, our system's strength has been our ability to organize our school trustees under the guiding principles of the Gospel to advance our shared goals for the promotion and protection of Catholic education in Ontario. We achieve those objectives through our ongoing lobbying efforts, our membership development services and the following key activities that directly benefit our members.

OCSTA:

- 1. Represents Catholic school boards on all provincial consultations and work groups.
- 2. Provides advice to boards on significant policy issues.
- 3. Provides an extensive array of classroom and community resources for Catholic Education Week. Information is located online at http://www.goodnewsforall.ca.
 - These resources resonate strongly with students, parents and parishes and boards have expressed their appreciation for the materials and information that are generated and shared.
- Lobbies the government on all funding issues most of which are identified by our member boards.
- Represents Catholic boards on significant legal issues as they arise.
- 6. Develops provincial messaging and platforms on key issues and developments in education affecting Catholic schools and shares such strategic resources with boards.
 - To further support effective school board communications and community relations, OCSTA hosts an annual professional development session for school board communication staff.
- 7. Provides enrichment opportunities for Catholic school board trustees and staff.
 - a. Supports online enrichment opportunities for Catholic school board trustees via the Trustee Professional Development Modules developed with input from OCSTA and delivered by the Ontario Education Services Corporation (OESC) which is supported by all Ontario's school trustee associations. Those modules can be accessed online at the following URL: https://modules.ontarioschooltrustees.org/?lang=en
 - Annual trustee development events include January Catholic Trustees Seminar, Business Seminar, Labour Relations sessions (as needed) and the Annual General Meeting and Conference.
 - c. The OCSTA Certificate Course in Leadership and Good Governance was made available to all trustees in 2019. Protects the interests of Catholic school boards by monitoring activity in the Legislature, including draft legislation, as well as the release of new Regulations to identify impact on Catholic boards and propose amendments as necessary.

- 8. Maintains a provincial network, at both the political and staff levels, to position OCSTA to respond quickly to any issue of relevance to Catholic Schools.
- 9. Serves as the designated bargaining agent for Ontario's 29 Catholic District School Boards.

This list is not exhaustive.

In addition, OCSTA partners with the other three trustee associations and the Council of Directors of Education (CODE) to provide many services, most with direct financial benefits to boards that are available only to boards that are members of their respective provincial association. Examples of the services provided through OESC include:

- Serving as the intervenor at the Ontario Energy Board to keep energy costs down for school boards. An estimate of savings over the past year of \$3M for Ontario's Catholic school boards. This translates into a savings of \$5.50 per pupil which exceeds the cost of OCSTA membership.
- Provision of Behaviour Management Systems. This training is required for certain staff and is offered at a rate that saves all school boards, public and Catholic, approximately \$2M annually.
- Supporting the trustee election process by providing an array of resources located at http://elections.ontarioschooltrustees.org that are designed to
 - o Raise the profile of trustee candidates and the municipal election process
 - Educate the public on the role of trustees and school boards
- Representation and co-ordination of initiatives pertaining to the Ontarians with Disabilities Act. This is ongoing and is meant to assist and guide boards through the various stages of implementation of the legislation and regulations. This service is a major savings for member boards that would otherwise be required to develop materials locally at significant expense.
- Development of resources on topics such as equity and inclusion, thereby saving each board the cost of developing such materials locally.
