1. Report from the Director of Education.

Stephen O'Sullivan, Director of Education, presented the Report from the Director of Education, which included the following points:

- Congratulations to Chairperson, Kevin MacKenzie and Vice-chairperson, Jenny Leahy who were elected to repeat their terms in their roles at the Annual Meeting on November 15. This board meetings marks the beginning of year two of the trustees' four-year term.
- Employees participated in the board-wide faith day on November 3 with a central online session with Father Dias and Nigaan Sinclair as well as local sessions and liturgies.
- The Boad retirement dinner was celebrated on November 10<sup>th</sup> and the attending retirees and their families were honoured for their years of service.

- Safe and Caring Schools week took place November 20<sup>th</sup> through 24<sup>th</sup> and coincided with the Ministry of Education's 'Bullying Awareness and Prevention Week'.
- Mid-term reports and student/parent consultations have taken place throughout the board.
- Congratulations to all sports teams in their endeavours, particularly to Holy Cross Catholic Secondary School's Junior Football team as they make history to be the third team from the Kawartha region to compete in the Metro Bowl championship.
- Thanks to schools who welcomed the Director of Education at visits to St Luke Catholic Elementary, St. Thomas Aquinas Catholic Secondary, St Dominic Catholic Elementary, St. John Paul II Catholic Elementary, St Mary Catholic Elementary, Lindsay, St Martin Catholic Elementary, St. Paul Catholic Elementary, Lakefield, St. Patrick Catholic Elementary, St. Anne Catholic Elementary, St. Paul Catholic Elementary, Peterborough, St. Teresa Catholic Elementary and St. John Catholic Elementary, Peterborough.
- The Director participated in a Public Sector Leadership Meeting for our region organized by MPP Dave Smith.
- Attended the English Catholic Council of Ontario Directors of Education (ECCODE) annual conference and general meeting, as well as a Council of Directors of Education professional development session on equity and diversity.

#### 2. Report from the Student Trustees.

Senior Student Trustee, Madelyn Gaskell and Junior Student Trustee, Claire Heitzner, gave the Student Trustee report which included the following highlights:

- PVNC Catholic schools celebrated Safe and Caring Schools Week on November 20<sup>th</sup> through 24<sup>th</sup> with activities such as distribution of kindness messages, a community wellness fair, and kind messages to teachers and staff acknowledging their work.
- St. Thomas Aquinas Catholic Secondary is in the giving spirit with their "Be an

Angel" Christmas giving program. The "No Stone Alone" project honoured veterans by having students visit graves at local cemeteries to learn about soldiers' contributions.

- Holy Cross Catholic Secondary school had many activities during November with the Welcome to Grade 8 students, Christmas Coffee House, Movie night, LINK activities, Football, Guatemala Fundraisers, and a visit from Bishop Miehm.
- St. Peter Catholic Secondary School has brought back the cheer team this year and has engaged in a Toy Drive, Wellness Wednesdays, and a successful Terry Fox Fundraising drive.
- St. Mary Catholic Secondary School held their Good News Assembly, Poutine Fest, and University Fairs. Student Drivers Education has also returned to the school.
- St. Stephen Catholic Secondary School has many Specialist High Skills Major activities happening, as well as a 'Be an Angel' program, post-secondary institution visits, and students are looking forward to the upcoming semi-formal dance.
- Holy Trinity Catholic Secondary held a Celebration of Learning to showcase student effort and achievements. The theatre production of 'Clue' held auditions, and the recent art night exhibition showcased plays, band performances and visual art displays.
- The Student Council Liaison Committee is excited to host the annual Student Leadership Retreat at Holy Trinity Catholic Secondary School on Friday, December 1<sup>st</sup>.

Student trustees Madelyn Gaskell and Claire Heitzner invited questions and comments from the trustees at the conclusion of their report.

#### 3. Report from the Communications Department.

Galen Eagle, Manager of Communications shared the system achievements from all areas of the board which included the following highlights and initiatives from the PVNC Inspires newsletter:

- Holy Cross Hurricanes Junior Football team has made Peterborough High School history by making it to the Metro Bowl finals in Toronto.
- Monsignor O'Donoghue Catholic Elementary School official opening and blessing
  of their outdoor learning space. Through a deep learning project, the students
  led the design and evolution of the outdoor space.
- A highlight of student programs for Remembrance Day, including 'No Stone Left Alone' which is a learning opportunity to honour veterans.

- Traveling artifacts of Saint Brother André were in Bowmanville. A Mass was celebrated at St. Joseph Church and presentations about the relics were given at St. Stephen Catholic Secondary School.
- A day in the life, highlighted the work of Sarah Keane, secretary at St. Joseph Catholic Elementary School, Bowmanville.
- Catholic Education Foundation of Ontario awards ceremony held in Toronto.
   One student celebrated from each secondary school across the province. Six PVNCCDSB students were recognized.
- Board retirement dinner was held on November 10, 2023 where almost 700 years of service was recognized in retiring teachers, administrators and support staff.
- St. Alphonsus Principal, Rebecca Brady recently kissed a guinea pig to come good on a promise to recognize funds raised by students.

At the conclusion of the report, Galen Eagle invited questions and comments from the trustees.

#### C. Presentations:

#### 8. <u>Providing Excellence in Teaching and Learning: Deep Learning.</u>

Sheila Piggott, Superintendent of Learning and Frank Bradica Principal of Information Technology gave a PowerPoint presentation detailing the PVNCCDSB Deep Learning implementation plan for the year. The plan includes principal network meetings, inschool professional development and implementation phases.

The presentation included specific examples of the types of learning activities and engagements that will enhance deep learning in our schools, thereby enhancing student achievement and well-being. Examples of the integration of many aspects of academic subjects and how they can intersect in student learning was discussed. A deep learning task has four elements: learning partnerships, learning environments, pedagogical practices, and leveraging digital resources and engages the 6 c's of character, citizenship, communication, collaboration, creativity, and critical thinking.

At the conclusion of the presentation, the trustees were able to ask questions of the presenters.

#### 9. Protecting the Environment.

Superintendent of Learning, Sheila Piggott and Learning Consultant, Michael Mooney delivered a presentation on the initiatives that are taking place in the board that are specific to the strategic priority of protecting the environment. The review of the program and learning activities included an overview of outdoor education and its connection to

Indigenous education.

Sheila Piggott and Michael Mooney responded to questions and comments from the trustees at the conclusion of their presentation.

#### 10. Ensuring Equity: Board Equity Action Plan.

Superintendent of Learning, Julie Selby introduced Benjamin Tenesia, Board Equity Advisor who gave a presentation about the development and implementation of the Board Equity Action Plan.

The structure of the plan was explained noting that each of the key priority areas: inclusive and responsive education, climate and prevention of discrimination and harassment, and religious accommodation has multiple actionable items. The governance and leadership of the plan are connected to the four pillars of accountability, transparency, responsibility, and fairness. Catholic Social Teachings are rooted in the equity actions and initiatives and affirm the dignity and worth of every student, staff and parent and community partner.

The next steps of the equity plan were explained. The public consultation ended on November 20<sup>th</sup> and the results will be reviewed and analyzed until December 8<sup>th</sup>. The equity action plan will be finalized in December, 2023. The implementation of the plan will take place in 2024 through to 2028.

The presenters answered questions posed by the trustees at the end of the presentation.

#### 1. Ontario Catholic School Trustees' Association (OCSTA) Open Session Report.

The Board Chairperson, Kevin MacKenzie, reported that communications from OCSTA have been shared throughout the month. Kevin MacKenzie noted that an OCSTA memo highlighted steps that the Ministry is taking to enhance curriculum to further Holocaust education, and education on the importance of safeguarding democracy.

Chairperson MacKenzie welcomed trustee comments regarding the OCSTA communications and invited trustees to contact him or the Director with any questions.

#### 2. STSCO Governance Committee, Open Session Report.

Kevin MacKenzie, Board Chairperson reported on the STSTCO Governance Committee meeting, open session, held on October 25, 2023. It was noted that a meeting was held

at Peterborough City Hall with city infrastructure staff members, Stephen O'Sullivan, Director of Education and Kawartha Pine Ridge District School Board Director of Education, Rita Russo. City staff confirmed that walkways leading to private property will no longer be maintained in winter months. This will increase walking distances for some students to get to school safely on cleared sidewalks. There will be further communication with STSCO and the boards to ensure a collaborative solution is sought.

#### Background:

The Education Act requires the Treasurer of the Board to furnish to the bank a copy of the resolutions(s) authorizing the borrowing of funds.

#### Operating

Each year, the Board is required to approve the Demand Operating Line-of-Credit to finance expenditures which occur before revenues are received. The current Line-of-Credit expires on December 31, 2023.

The \$10,000,000 level for the Operating Line-of-Credit provides coverage for any fluctuations in cash flow during the year. The cost to the Board is determined by the amount that must be drawn against this Line-of-Credit. The interest on the Operating Line-of-Credit is Prime which is currently at 7.2%. The Board has not drawn on this credit facility for a number of years.

#### Capital - Interim Financing of Construction Projects

Capital cash flow payments provided through the School Condition Improvement funding stream are flowed to the board subsequent to the actual expenditures being incurred and reported to the Ministry of Education. Capital spending is reported to the province as of March 31st and August 31st each year as part of the March report and the annual financial statements. Cash transfer payments for the incurred expenditures are received twice per year and School Boards receive funding from the Ministry of Education for their short-term interest costs incurred on projects that are underway.

The School Condition Improvement funding allocation for the 2023-24 school year is \$5,478,159. The Board has approached the Canadian Imperial Bank of Commerce requesting short-term bridge financing, variable rate interest payable monthly, and principal repayable in total upon receipt of permanent financing to meet capital cash flow needs.

- B. Pursuant to Subsection 243(3) of the Act, the total amount borrowed pursuant to this Resolution together with the total of any similar borrowings and any accrued interest on those borrowings is not to exceed the unreceived balance of the estimated revenues of the Board for the Period.
- C. The total amount previously borrowed by the Board pursuant to Section 243 that has not been repaid is \$0.
- D. The amount borrowed for current expenditures is within the Board's Debt and Financial Obligation Limit as established by the Ministry of Education and Training from time to time.

#### **RESOLVED THAT:**

- 1. The Chair or Vice Chair and the Treasurer are authorized on behalf of the Board to borrow from time to time by way of promissory note, or overdraft, or bankers' acceptance from Canadian Imperial Bank of Commerce ("CIBC") a sum or sums not exceeding in the aggregate Ten Million Dollars (\$10,000,000) to meet, until current revenue is collected, the current expenditures of the Board for the Period (including the amounts required for the purposes mentioned in Subsection 243(1) and 243(2) of the Act), and to give to CIBC promissory notes or bankers' acceptances, as the case may be, sealed with the corporate seal of the Board and signed by any two of the Chair or Vice Chair and the Treasurer for the sums borrowed plus interest at a rate to be agreed upon from time to time with CIBC;
- 2. The interest charged on all sums borrowed pursuant to this Resolution plus any related charges, is not to exceed the interest that would by payable at the prime lending rate of the chartered banks listed in Schedule 1 of the Bank Act (Canada) on the date of borrowing;
- 3. The Treasurer is authorized and directed to apply in payment of all sums borrowed plus interest, all of the moneys collected or received in respect of the current revenues of the Board;
- 4. The Treasurer is authorized and directed to deliver to CIBC from time to time upon request a statement showing (a) the total amount of unpaid previous borrowings of the Board for current expenditures together with debt charges, if any, and (b) the uncollected balance of the estimated revenues of the previous year less any current revenue already collected.

#### 1 Introduction

Aligned with the Peterborough Victoria Northumberland and Clarington Catholic District Schools Board's Pillar of Being Well, the Administrative Procedure for Occupational Health and Safety, as well as, the Ontario Occupational Health and Safety Act, PVNCCDSB is committed to providing and maintaining a healthy and safe workplace by complying with all relevant health and safety legislation. In an effort to support the employer with its health and safety commitment, as well as to ensure employee voice in regards to health and safety, the Joint Health and Safety Committee meets five times per school year to review, update and provide guidance on health and safety related matters. All PVNCCDSB properties are inspected monthly by Work Site Inspection Committees.

This report summarizes the health and safety activities undertaken by the Joint Health and Safety Committee during the period July 2023 – December 2023 and demonstrates the commitment of the PVNC Catholic District School Board, schools, administrative sites and the committee to be compliant with the requirements of health and safety legislation.

#### 2 Highlights from July 2023 to December 2023

- The JHSC engaged in a consultation process and provided feedback on Board Administrative Procedures that require an annual review. The APs reviewed were:
  - AP 809 Occupational Health & Safety
  - AP 508 Workplace Harassment Prevention
  - o AP 509 Workplace Violence Prevention
- The JHSC thanked outgoing members of the committee and welcomed new members:
  - Nora Shaughnessy, CUPE
  - Karen Spenceley Principal / Vice Principal

Nora Shaughnessy is a fully certified JHSC representative. Karen Spenceley completed Part 1 JHSC Certification upon joining the JHSC. All other committee members have either Part 1 or are fully certified.

- The JHSC acknowledged Richard Driscoll, Manager of Facility Services, for his service to the committee. Richard attended his last meeting in December 2023 and moves into retirement.
   The committee will welcome a new management representative to the committee shortly.
- Annually the Facility Services department has an outside consultant undertake a review of
  designated substances in our workplaces. The JHSC is provided access to these reports as
  required by the OHS Act, Section 9(18). In the fall of 2023 the JHSC reviewed the annual
  Designated Substances reports and brought forward by Facility Services to identify any
  recommendations that may stem from the findings.
- At the December 5, 2023 meeting the JHSC discussed which schools would be audited by the JHSC this year. The purpose of these audits is to ensure compliance with health and safety expectations. During this school year, the JHSC will audit the following work locations:
  - St. Elizabeth Catholic Elementary School and Annex
  - St. Joseph Catholic Elementary School (Bowmanville)
  - St. Martin Catholic Elementary School
  - Immaculate Conception Catholic Elementary School
  - Monsignor O'Donoghue Catholic Elementary School
  - St. Michael Catholic Elementary School
- The JHSC provided the employer with feedback regarding potential improvements to the HR5 -Incident/Accident Reporting Form.

#### 3 Upcoming/Ongoing Projects



- The JHSC will continue to monitor accident and incident statistics as provided at each JHSC meeting and will recommend preventive measures to the Employer as they are identified.
- The JHSC continues to support a sub-committee with a focus on workplace violence and what supports can be provided to support schools.
- The sub-committee of the JHSC will provide consultation on a new Administrative Procedure -Asbestos Management Program in advance of the AP being presented at Policy Committee.

#### 4 Learning Opportunities

- In line with the JHSC's 2023/ 2024 goal of 'a continued focus on improving the skill set and knowledge level of the JHSC members', at the October meeting of the JHSC, the committee attended a webinar entitled "Harnessing you JHSC's Greatness" which was provided by Workplace Safety & Prevention Services. The webinar focussed on best practices of Joint Health & Safety Committees. The committee subsequently provided feedback on the webinar and engaged in discussion on what improvements could be made.
- Work Site Inspection Committee Representative (WSICR) training the committee encouraged
  the employer to move back to in-person training for WSICR. The training was held on September
  29, 2023 and was facilitated by Melissa Featherstone, Health & Safety Officer. Joseph DeVuono,
  Co-Chair of the JHSC was also in attendance and assisted in a facilitated review of potential
  workplace hazards. Twenty-four (24) employees attended in-person training, with remaining
  trainees completing the program via online training.

#### 5 Incident Reporting

Incident Type Totals July 1 2023 – Nov 30 2023

For the period of July 1 2023 - Nov 30 2023, there have been 403 total incident reports placed.

The most reported incident types being:

- (1) Workplace Violence
- (2) Struck or Contact By
- (3) Struck Against
- (4) Overexertion

Of 403 the incident reports received in the time period of July – December, 21 have resulted in staff having lost-time or seeking health care. These incidents are reported to WSIB as compensable injuries. 10 of these incidents resulted in staff losing time from work beyond the date of injury.



11 of these incidents resulted in health care only, no lost time.

NOTE- Inspection completion rates historically decline over the summer. The JHSC has been working to raise awareness of the need to continue to submit inspections in summer months.

#### 2023 -2024 JHSC Goals / Priorities

The Joint Health and Safety Committee has worked towards our 2023-2024 priorities with the following efforts:

- Increased education for workers regarding the Internal Responsibility System in an effort to ensure
  all employees know their responsibilities as they relate to health & safety the committee will
  reinforce the Internal Responsibility System with staff over the course of the year.
- Focus on Workplace Violence Prevention-
  - Sub-Committee work on the topic- the sub-committee brought forward a recommendation to the JHSC which was endorsed and submitted to the Director of Education on November 15th 2023. A response was received within the required 21 day response time, on December 4, 2023.
  - o Ongoing JHSC Meeting review and discussion pertaining to WV Incident Reports
- Struck/ Contact By Incidents- The committee continues to review accident/ incident data in regards to preventive measures that may be taken to mitigate risk in this area.

#### 7. 2023 -2024 JHSC Goals / Priorities

#### The Joint Health & Safety has committed to the following priorities for the 2023-2024 school year.

- Increased education for workers regarding the Internal Responsibility System in an effort to
  ensure all employees know their responsibilities as they relate to health & safety.
- Improve the JHSC's analysis of workplace incidents through an increased focus on the evaluation of risk assessment (probability and severity) of incidents.
- Continued focus on the Struck / Contact By Incidents in an effort to mitigate risk in that area.
- Continued focus on improving the skill set and knowledge level of the JHSC members. The JHSC
  aims to again attend a skill building PD workshop on a relevant and timely topic next school year,
  as historically has been done each year.


"There are many rooms in my Father's house; if there were not, I should have told you.

Fr. Pat served as OCSTA Chaplain from 2002 to the present, offering guidance and support to members and to staff, teaching us to grow in our relationship with Christ and others.

To many of us, in Fr. Pat, we saw the face of God. Through his homilies, his reflections, and his presence he brought calm, peace, joy and hope.

For many years Fr. Pat advised and inspired Catholic education leaders in Ontario, but most importantly he has informed the minds of young people, serving as an English, French and Religious Education teacher at Neil McNeil Catholic High School, Metropolitan Separate School Board (Toronto CDSB) from 1964-1979. He later served as Adult Faith Formation Coordinator from 1980-87.



From 1991-1999 he served as Adult Faith Formation Coordinator at the Dufferin-Peel CDSB. He continued to build relationships with Ontario's Catholic students giving of himself and his time through his participation in school liturgies. Catholic educators and trustees benefited greatly from Fr. Pat's pastoral care which has taken many forms. From his ever poignant homilies to workshops that he developed, notably the "Build Bethlehem" Workshop, which focused on the ways in which we relate to each other as people rooted in the teachings of the Gospel.

Fr. Pat was Co-Editor of SPIRITAN, a quarterly magazine of the Spiritans/Holy Ghost Fathers and was involved with "Becoming Neighbours", an outreach group of Toronto-based Religious Communities focused on immigrants and refugees. For many years Fr. Pat was celebrant of the Friday Mass on Vision Television, bringing the gift of Christ's gospel to those who are shut-in.

We are grateful for Fr. Pat's many years of leadership and his constant heartfelt commitment to the people who lead and give life to Catholic education in Ontario.

Please pray for the repose of the soul of Fr. Pat and for the Spiritan community.






