#### A. Call to Order of the Open Meeting:

The Board Chairperson, Kevin MacKenzie, called the meeting to order at 6:40 p.m. and welcomed guests attending in person and guests who were joining the meeting online by Google Meet.

The Board Chairperson welcomed the Principal/Vice-principal representatives, Laura Carson, Principal at St. Dominic Catholic Elementary School, Kim Fletcher, Principal at St. Joseph Catholic Elementary School, Cobourg, and Claire Wilson, Vice-principal at Holy Cross Catholic Secondary School.

#### B. Reports from the Office of the Director and Student Trustees:

1. Report from the Director of Education.

Stephen O'Sullivan, Director of Education, presented the Report from the Director of Education, which included the following points:

- The PVNC Catholic community mourns the death of Pope Francis and remember his service and compassion for the marginalized.
- Easter blessings were wished for trustees, staff, students and their families.
- The federal election was acknowledged, and prayers were offered to the elected leaders in their roles.

- Appreciation was expressed to all who supported our board during the power outages due to the significant ice storm. Facilities services and custodians were diligent, ensuring a safe return to school.
- Strategic consultations are ongoing in preparation for the renewed strategic priorities for PVNC Catholic.
- The Name Change Committee has reviewed the data gleaned from the online consultation process and it has been decided that the board will not adopt a new name.
- Recently met with MPP Dave Smith to discuss local issues relevant to education and our board.
- The board welcomed Dr. David Tranter for a parent engagement session. Dr. Tranter is a psychologist recognized for his research work with trauma informed practices.
- A "Math at Home" session focusing on better understanding of EQAO assessments was held for parents.
- The director attended an Eastern Ontario Staff Development Network (EOSDN) session in Kingston which provided an excellent opportunity to collaborate with other senior school board leaders.
- Gratitude was extended to Maria Fitzgerald and the volunteers of the Rosary Apostolate Program, who attend our schools and provide a learning opportunity for students to engage in Mary traditions and pray the Rosary.
- Congratulations to Pat Daly who has been named as the new Executive Director of the Ontario Catholic School Trustees Association, replacing Nick Milanetti who will retire this year.
- April 28<sup>th</sup> was the National Day of Mourning for Workers Injured or Killed in the Workplace and was recognized at PVNC Catholic with flags at all schools and the Catholic Education Centre at half-mast.
- Congratulations to Vivica Muinde, who will be the Junior Trustee for the 2025-2026 school year, elected tonight by the Student Council Liaison Committee.

Stephen O'Sullivan invited and answered questions from the trustees at the conclusion of the report.

#### 2. <u>Report from the Student Trustees.</u>

Senior Student Trustee, Claire Heitzner and Junior Student Trustee, Carter Peios, gave the Student Trustee report which included the following highlights:

• The Student Council Liaison Committee elected Vivica Muinde from Holy Trinity Catholic Secondary School as the in-coming Junior Student Trustee. -

- The St. Stephen Catholic Secondary School Specialist High Skills Major students were busy with certifications and trips throughout the month. The senior dodgeball tournament was held with Durham Regional Police Services participating. The musical production of "You're a Good Man, Charlie Brown" will be held May 8-10.
- The Holy Trinity Catholic Secondary School student cabinet hosted their annual Easter spirit week. The annual Dodgeball tournament was a success and the Grade 12 students prepared for graduation at the annual Grade 12 Day. Throughout the month of April, funds were raised for Autism Homebase. The activities raised awareness to honour those living with Autism.
- The game of Spoons is back at St. Thomas Aquinas Catholic Secondary School with 90 students participating. Some students will be visiting the Netherlands during May and some Grade 11 students traveled to a local mosque to gain insights for their world religion class.
- At Holy Cross Catholic Secondary School, the badminton team met great success at the COSSA tournament. The annual cake auction for special education was very competitive and a successful fundraiser.
- Students at St. Peter Catholic Secondary School showed their care for the community through their recent blood drive. Jeff Martin, a motivational speaker, visited for a recent assembly. Science students made a trip to Queens University to experience their cadaver laboratory.
- St. Mary Catholic Secondary School Learning Life Skills class hosted other schools for their annual Spring Fling dance. Environmental SHSM students traveled to Ganaraska for experiential learning and the Choir is preparing to travel to Ireland for a competition.

Student trustees Claire Heitzner and Carter Peios invited questions and comments from the trustees at the conclusion of their report.

#### 3. Report from the Communications Department.

Galen Eagle, Manager of Communications, shared the following system highlights and initiatives:

- Catholic Education Week will be celebrated from May 4-9, 2025. A video message for Catholic Education Week from Bishop Daniel Miehm was viewed.
- The 2025-2026 School Year Calendar has been approved by the Ministry of Education and is available on the Board website.
- The annual Math Olympics were held on April 24<sup>th</sup>. There were 250 students from Grades 3-8 participating from all areas of the school board.
- Teams from PVNC Catholic schools competed at regional robotics competitions

held at Ontario Tech University in Oshawa at the end of March. A team from St. Joseph Catholic Elementary School in Bowmanville advanced to the Skills Ontario competition being held in May.

- PVNC Catholic students were successful at the Peterborough Regional Science Fair. Claire Sehn from St. Catherine Catholic Elementary School researched fire-retardant products and qualified to compete at the Canada-wide Science Fair being held in New Brunswick this year.
- 75<sup>th</sup> Anniversary of Catholic Education at St. Alphonsus CES will be celebrated on Tuesday, May 6, 2025.
- Grade 8 students at St. Joseph Catholic Elementary School are carrying on the tradition of ringing the church bell at St. Joseph Church in Douro.
- St. Stephen Catholic Secondary School is staging the musical, "You're a Good Man Charlie Brown" from May 8-10<sup>th</sup>.
- Holy Trinity Catholic Secondary School students collected over 1,600 pairs of shoes for the "Soles4Souls" organization, which assists communities in developing countries.
- A school-wide Black History conference took place at St. Anne Catholic Elementary School where students shared their learning with other students who visited their classroom.
- Students from Monsignor Leo Cleary Catholic Elementary School were awarded a bronze medal at the Clarington Public Library Battle of the Books.
- The Director of Education engaged in Strategic Planning visits at various schools. Kindergarten students at St. Francis of Assisi Catholic Elementary School presented him with a book created by them of what they think the Director does.

At the conclusion of the report, Galen Eagle invited questions and comments from the trustees.

#### C. Presentations:

1. <u>Providing Excellence in Teaching and Learning: Student Achievement Plan.</u>

Superintendents Jonathan Di Ianni, Sheila Piggott, and Julie Selby gave a presentation to inform the trustees about the Student Achievement Plan for PVNCCDSB.

With the use of data, the superintendents identified and explained the year two goals and specific actions in Literacy and Math, which fall under the first priority of improved Achievement of Learning Outcomes in Core Academic Skills. The second priority for the board is Preparation of Students for Future Success. The year two goal is to improve graduation rates and preparedness for future success which relate to data reflecting credit accumulation, participation in job skills training, attainment of the Ontario Secondary School Diploma, and credit attainment in Math or Science. Each of the goals and their respective actions were described.

Student Engagement and Well-being is recognized as the third priority. The goals under this priority are to Improve Student Participation in Class Time and Learning and Improve Student Well-being. Specific actions in the areas of attendance and suspensions that will be engaged to improve indicator data were reviewed.

The next steps in the Student Action Plan were explained and will include the publishing of the plan on the board website and its submission to the Ministry of Education by the end of June.

The student achievement plan data will be used with other data gathered, such as school climate survey data to identify areas of growth and will assist the formation of the next Catholic Board Improvement Plan for Student Achievement and Well-being, and the Catholic School Improvement Plans for Student Achievement and Well-being.

The chairperson called a brief recess at 7:45 p.m. The meeting resumed at 7:49 p.m.

2. Nurturing Mental Health and Well-being: 2025 Mental Health and Well-being Updates.

Superintendent Jonathan Di Ianni introduced Dr Cynthia Chan Reynolds, Board Psychologist and Jennifer Angelo, Board Mental Health Lead who gave a presentation about the Mental Health and Well-being initiatives being undertaken at PVNC Catholic.

The presentation included an overview of the professional development that has been delivered to administrators and teaching staff this year and a brief explanation of each type of training that was provided. In addition, the presenters reviewed procedures that were recently updated and the ongoing work to streamline resources and response to student and staff needs.

Ongoing work such as classroom presentations, participation in the Peterborough Community Resilience Project, supporting parent engagement, and the promotion of the parent resource from School Mental Health Ontario 'By Your Side' was reviewed. The work of the social worker teams was highlighted and future work which is planned for summer programing and for the fall of 2025 was reviewed.

At the conclusion of the presentation the trustees had the opportunity to have their questions answered by the presenters.

Chairperson Kevin MacKenzie highlighted communications that were received from OCSTA during the month of April which included the report on Anti-Black Racism in Education from the Ontario Human Rights Commission, the OCSTA 2025 AGM Resolutions package, the program for the OCSTA 95<sup>th</sup> AGM and Conference, and the Trustee Professional Development Essential Training. Chairperson MacKenzie also noted the official statement from the Canadian Conference of Catholic Bishops regarding the passing of our Holy Father, Pope Francis.

#### SUBJECT: Updated Mandatory Training for Trustees

The Ministry of Education has revised the requirements of its "Essential Governance Training" mandate previously announced and shared by OCSTA at the recent Catholic Trustees Seminar. The Ontario Education Services Corporation (OESC), which works collaboratively with all trustee associations in Ontario, has been selected by the Ministry of Education to develop and deliver a mandatory professional development training program designed for school board trustees and directors of education. This program will support sector implementation of the recent regulatory amendments set out in *The Better Schools and Student Outcomes Act*.

#### **ABOUT THE PROGRAM**

OESC's *Essential Governance 2025* professional development program will focus on these key areas of governance:

- Mediation and Conflict Resolution
- Financial Management and Governance
- Effective Community Engagement to Promote Student Achievement
- Director of Education Performance Appraisal

All Ontario school board trustees and directors of education are expected to complete the training program as follows:

#### Part 1 – Essential Governance 2025 Self-directed Online Modules

All Ontario school board trustees and directors of education are expected to complete the new *Essential Governance 2025* self-directed <u>online learning modules</u> which will be made available on OESC's Good Governance website by April 28, 2025. The program includes six modules, each available in English and French:

- Module 5: Director of Education: Hiring and Performance Appraisal (the "Hiring" content in this module is new)
- Module 8: Understanding Conflict and Managing it Effectively
- Module 9: Effective Community Engagement to Support Student Achievement
- Module 13: Education Finance
- Module 17: Trustee Code of Conduct
- Module 19: Audit and the Role of Audit Committees

Each trustee association and CODE has contributed to the creation of the modules. Upon completion of the modules, trustees and directors of education will receive a certificate of completion in recognition of their commitment to the good governance of their boards. Data on participant completion will be made available to the Ministry of Education.

#### Part 2 – Essential Governance 2025 Webinars

OESC and the trustee associations will develop a series of facilitated professional development webinars focused on the four key governance areas. The sessions will build on the learning provided in the online modules.

OPSBA and OCSTA trustees will join English-language directors of education for webinars delivered in English. ACÉPO and AFOCSC trustees will join French-language directors of education for webinars delivered in French. Webinars will be facilitated by experts with experience in both public and Catholic education (*see webinar presenters names in chart below*).

#### The webinars will take place in Spring 2025—OCSTA will provide registration information

and dates when details are confirmed. Participants are encouraged to attend the online/synchronous learning sessions; however, sessions will be recorded and made available on OESC's Good Governance website. Participant data on both synchronous and asynchronous webinars will be shared with the Ministry of Education.

#### WE HAVE A POPE

The Most Eminent and Most Reverend Lord Robert Francis Cardinal of the Holy Roman Church Prevost who has taken the name Leo XIV

Just a few moments ago, from the central loggia of Saint Peter's Basilica, Cardinal Protodeacon Dominique Mamberti pronounced the formula "Habemus Papam," proclaiming to the city of Rome and to the whole world the news of the election of Robert Francis Cardinal Prevost as Pope Leo XIV.

#### Leo XIV - Second Pope from the Americas

The first Augustinian Pope, Robert Prevost - now Leo XIV - is the second Roman Pontiff from the Americas after Pope Francis. However, unlike Jorge Mario Bergoglio, the 69-year-old Robert Francis Prevost is from the northern part of the American continent, though he spent many years as a missionary in Peru before being elected head of the Augustinians for two consecutive terms.

#### **First Augustinian Pope**

The new Bishop of Rome was born on September 14, 1955, in Chicago, Illinois, to Louis Marius Prevost, of French and Italian descent, and Mildred Martínez, of Spanish descent. He has two brothers, Louis Martín and John Joseph.

He spent his childhood and adolescence with his family and studied first at the Minor Seminary of the Augustinian Fathers and then at Villanova University in Pennsylvania, where in 1977 he earned a Degree in Mathematics and also studied Philosophy.

On September 1 of the same year, he entered the novitiate of the Order of Saint Augustine (O.S.A.) in Saint Louis, in the Province of Our Lady of Good Counsel of Chicago, and made his first profession on September 2, 1978. On August 29, 1981, he made his solemn vows.

He received his theological education at the Catholic Theological Union in Chicago. At the age of 27, he was sent by his superiors to Rome to study Canon Law at the Pontifical University of Saint Thomas Aquinas (Angelicum).

In Rome, he was ordained a priest on June 19, 1982, at the Augustinian College of Saint Monica by Monsignor Jean Jadot, then Pro-President of the Pontifical Council for Non-Christians, now the Dicastery for Interreligious Dialogue.

Prevost obtained his licentiate in 1984; and the following year, while preparing his doctoral thesis, was sent to the Augustinian mission in Chulucanas, Piura, Peru (1985–1986). In 1987, he defended his doctoral thesis on "The Role of the Local Prior in the Order of Saint Augustine" and was appointed vocation director and missions director of the Augustinian Province of "Mother of Good Counsel" in Olympia Fields, Illinois (USA).

#### **Mission in Peru**

The following year, he joined the mission in Trujillo, also in Peru, as director of the joint formation project for Augustinian candidates from the vicariates of Chulucanas, Iquitos, and Apurímac.

Over the course of eleven years, he served as prior of the community (1988–1992), formation director (1988–1998), and instructor for professed members (1992–1998), and in the Archdiocese of Trujillo as judicial vicar (1989–1998) and professor of Canon Law, Patristics, and Moral Theology at the Major Seminary "San Carlos y San Marcelo." At the same time, he was also entrusted with the pastoral care of Our Lady Mother of the Church, later established as the parish of Saint Rita (1988–1999), in a poor suburb of the city, and was parish administrator of Our Lady of Monserrat from 1992 to 1999.

In 1999, he was elected Provincial Prior of the Augustinian Province of "Mother of Good Counsel" in Chicago, and two and a half years later, the Ordinary General Chapter of the Order of Saint Augustine, elected him as Prior General, confirming him in 2007 for a second term.

In October 2013, he returned to his Augustinian Province in Chicago, serving as director of formation at the Saint Augustine Convent, first councilor, and provincial vicar—roles he held until Pope Francis appointed him on November 3, 2014, as Apostolic Administrator of the Peruvian Diocese of Chiclayo, elevating him to the episcopal dignity as Titular Bishop of the Diocese Sufar.

He entered the Diocese on November 7, in the presence of Apostolic Nuncio James Patrick Green, who ordained him Bishop just over a month later, on December 12, the Feast of Our Lady of Guadalupe, in the Cathedral of Saint Mary.

His episcopal motto is "In Illo uno unum"—words pronounced by Saint Augustine in a sermon on Psalm 127 to explain that "although we Christians are many, in the one Christ we are one."

#### Bishop of Chiclayo, Peru, from 2015 to 2023

On September 26, 2015, he was appointed Bishop of Chiclayo by Pope Francis. In March 2018, he was elected second vice-president of the Peruvian Episcopal Conference, where he also served as a member of the Economic Council and as president of the Commission for Culture and Education.

In 2019, Pope Francis appointed him a member of the Congregation for the Clergy (July 13, 2019), and in 2020, a member of the Congregation for Bishops (November 21). Meanwhile, on April 15, 2020, he was also appointed Apostolic Administrator of the Peruvian Diocese of Callao.

#### Prefect of the Dicastery for Bishops

On January 30, 2023, the Pope called him to Rome as Prefect of the Dicastery for Bishops and President of the Pontifical Commission for Latin America, promoting him to the rank of Archbishop.

#### **Created Cardinal in 2024**

Pope Francis created Prevost Cardinal in the Consistory of September 30 of that year and assigned him the Diaconate of Saint Monica. He officially took possession of his Titular church on January 28, 2024.

As head of the Dicastery, he participated in the Pope's most recent Apostolic Journeys and in both the first and second sessions of the 16th Ordinary General Assembly of the Synod of Bishops on synodality, held in Rome from October 4 to 29, 2023, and from October 2 to 27, 2024, respectively.

Meanwhile, on October 4, 2023, Pope Francis appointed him as a member of the Dicasteries for Evangelization (Section for First Evangelization and New Particular Churches), for the Doctrine of the Faith, for the Eastern Churches, for the Clergy, for Institutes of Consecrated Life and Societies of Apostolic Life, for Culture and Education, for Legislative Texts, and of the Pontifical Commission for the Vatican City State.

Finally, on February 6 of this year, the Argentine Pope promoted him to the Order of Bishops, granting him the title of the Suburbicarian Church of Albano.

## **OUR CATHOLIC IDENTITY: SACRED SCRIPTURE**



"We should never take God's word for granted, but instead let ourselves be nourished by it, in order to acknowledge and live fully our relationship with him and with our brothers and sisters." Pope Francis



To say that our Catholic identity is rooted in Scripture is already to say quite a lot. First of all, it is to say that who we are as Catholic Christians is part of a story—actually, a very ancient, rich and nuanced story, which is the story of God's love for humanity. As we know, it is a story that begins with God creating the cosmos and then, over time, choosing for Himself a family and a people who would be His partners in a unique covenant relationship that, through millennia of highs and lows, brings to the life, ministry, death and resurrection of Jesus. Scripture reminds us that our story is part of a much larger Story, and it invites us to situate ourselves within the long unfolding of God's unshakeable love for humanity. Scripture reminds us that, as Catholic Christians, we are heirs to that covenant relationship, and are called to embody it in our own lives and choices.

To speak of our Scriptural identity as Catholics is also to remind us of all of the amazing ancestors in faith that we can look to as models and intercessors. We think about inspiring Old Testament characters like Abraham and Sarah, Moses, Joshua, Esther, and the Hebrew Prophets. And, in the New Testament, we have the radiant model of the Virgin Mary, Jesus' mother—and figures like St. Peter, St. Paul, and all of the Apostles, the first evangelizers, who staked everything on their relationship with Jesus, giving witness to the Risen Lord even to the point of giving up their lives. Even 2000 years later, the example of their lives still speaks powerfully to us, reminding us of what a Christ-centred life can look like. And the Church has always counted the great figures of both testaments as saints, so we can also ask their prayers and intercession as we try to live faithfully here below.

If our identity is grounded in the Bible, then that means our identity also involves relationships. Of course, we share the first portion of the Bible —the Old Testament—with our Jewish sisters and brothers, reminding us of the unique familial relationship we have with them. But the Scriptures are the common heritage of all Christians, and so we share them in common with all believers in Jesus, whether Anglicans, Eastern Orthodox, Presbyterians, Methodists, Lutherans, United Church of Canada members, and those belonging to various Evangelical Christian communities. If we take Scripture seriously, then we realize that our identity necessarily involves loving relationships with other Christians, and with the Jewish people. Scripture sketches out our identity-asfamily.

Last but not least, a Biblically-rooted identity for us as Catholic Christians calls us to obedience to God's Word. Not the kind of obedience rooted in fear or poor self-image, but the kind that remembers the linguistic roots of "obedience": the Latin ob + audire (roughly, "to listen in a certain direction, or with a certain goal"). To be "obedient" to God's Word means that we must listen to it as it is proclaimed in the Church's liturgies, and as we encounter it in our own meditative reading and personal prayer. If we as Catholics believe that our identity is rooted in Scripture, then we will want to return to it lovingly, over and over again, to absorb its message over time and allow it to shape our minds and hearts.

In his 2010 exhortation Verbum Domini (On the Word of God in the Life and Mission of the Church), Pope Benedict XVI wrote of "my heartfelt hope for the flowering of 'a new season of greater love for sacred Scripture on the part of every member of the People of God, so that their prayerful and faith-filled reading of the Bible will, with time, deepen their personal relationship with Jesus." As so many great saints and Christian spiritual writers have emphasized, Scripture is what enables us to truly understand our deepest identity—as children of God, brothers and sisters of Jesus through our baptism. By taking the time to regularly read and pray with Scripture, we will come to grasp who we are—and whose we are—and to shape our lives in a way that is authentically in keeping with that identity ... in a way that our world can see, and be drawn to believe.

### HOW CAN WE MAKE SCRIPTURE A PART OF OUR DAILY LIVES?

#### DAILY BIBLE READING:

Spend 10-15 minutes a day reading the Bible. Begin with the sign of the cross, take a moment of silence and then read the passage. Reflect on the following questions:

- What does it say?
- What does it mean?
- What does it mean to me?
- What am I going to do about it?

#### **LECTIO DIVINA:**

Lectio Divina is a method of reading Scripture This involves reading a Gospel passage slowly, first out loud and silently, and then contemplating the words for their spiritual meaning. This deepens connection and appreciation of the Bible.

Lectio Divina traditionally consists of four simple steps:

- Reading (lectio): Read a passage of Scripture slowly and attentively.
- Meditation (meditatio): Meditate on the passage, turning it over in your mind and connecting it with other passages in the Bible.
- Prayer (oratio): Respond to God in prayer, telling him your thoughts, questions, hopes, fears, and desires as they relate to the passage.
- Contemplation (contemplatio): Rest in God, enjoying his presence and receiving his love.

### **MARY IN SCRIPTURE**

The Bible presents Mary as a model of faith, humility, and obedience to God's will, and Catholic tradition sees her as an essential part of salvation history. Through both her own experiences and her role as the Mother of the Church, Mary's life continues to be deeply intertwined with Scripture, and she is seen as an example for all Christians to follow.

Mary's presence throughout the Scriptures (especially in the Gospels) highlights her importance. The Annunciation (Luke 1:26-38) marks the beginning of her role in salvation history, while the Visitation (Luke 1:39-56) reveals her humility and joy in serving others. In addition, her role in John 2:1-11 at the Wedding Feast of Cana, where she intercedes for the couple and prompts Jesus to perform His first miracle, exemplifies her role as an intercessor.

My soul proclaims the greatness of the Lord, my spirit rejoices in God my Savior, for he has looked with favor on his humble servant.


From this day all generations will call me blessed, the Almighty has done great things for me, and holy is his Name.





SUBJECT:	Bill 17: An Act to amend various Acts with respect to infrastructure, housing and transit and revoke a regulation

On Monday May 12, 2025, the Minister of Municipal Affairs and Housing introduced Bill 17 that proposes various amendments to municipal infrastructure and capital planning. In respect of the Bill's implications for school boards, Schedule 3 City of Toronto Act, the following amendments are proposed:

The Schedule amends section 114 of the City of Toronto Act, 2006 to remove the timing restrictions with respect to when a <u>portable classroom was placed on a school site for the</u> <u>purposes of the definition of "development" in subsection</u> 114 (1) of the Act. The Act is also amended to provide certain rules with respect to information and material prepared by a person authorized to practice a prescribed profession.

In addition, Schedule 7 Planning Act, the Bill proposed the following amendments:

- 1. Section 16 of the Act is amended, and new section 35.1.1 is added to the Act. These provisions provide for restrictions on official plans and zoning by-laws with respect to prohibiting the using a parcel of urban residential land for an elementary school, a secondary school, or a use ancillary to such schools.
- 2. New subsections 17 (21.1) and (21.2) of the Act require the council of a municipality or the planning board to obtain the Minister's approval before making certain amendments to an official plan.

- 3. New subsections 34 (1.4) to (1.7) of the Act set out rules with respect to minimum instances that buildings on certain lands must be setback from parcel boundaries.
- 4. Section 41 of the Act is amended to remove the timing restrictions with respect to when a portable classroom was placed on a school site for the purposes of the definition of development in subsection 41 (1) of the Act.
- 5. Section 47 of the Act is amended to provide that the Minister may, in certain orders made under that section, impose conditions on the use of land or the erection, location, or use of buildings or structures.

In summary, these and other changes will streamline planning approvals for schools. For example:

- Exempt the placement of all portable classrooms at public school sites from site plan control. Currently, public school sites built prior to January 1, 2007, are exempt from site plan control when adding a portable classroom. This change would extend the exemption to all school sites.
- Amend the Planning Act to provide explicit permission for the use of Kindergarten to Grade 12 public schools and ancillary uses (such as associated childcare) on urban land zoned for residential uses "as-of-right". In some cases, this could remove the need for a rezoning application, saving approximately 6-18 months from the approvals process.

On Thursday May 15, 2025, the Ontario Minister of Finance, Peter Bethlenfalvy, released the 2025-26 provincial budget entitled "a Plan to Protect Ontario."

The budget included the following new funding initiatives that will be of interest to Catholic boards:

- \$16.5 million in the Black Youth Action Plan to assist youth build career skills in demand sectors;
- \$12.8 million in the Anti-Hate Security and Prevention Grant to enhance security for faith based organizations;
- \$2 billion in the 2025-2026 school year to improve and modernize school infrastructure;
- \$55.8 million to hire new teachers;
- Increasing its investment in the Ontario Autism Program by \$175 million in 2025–26, bringing this year's total funding to \$779 million;
- Overall expenditure in the education sector: \$41 billion.

OCSTA will on behalf of Catholic School Boards advocate strongly for additional funding with regard to planning for the 2025/2026 school year. We will continue to impress upon the Ministry of Education the need to provide sufficient resources to support the health and safety of students and staff as well as the necessary funding for mental health, student transportation, special education, and capital planning.
