## A. Call to Order of the Open Meeting:

The Board Chairperson Braden Leal called the online meeting to order at 6:31 p.m.

## B. Reports from the Office of the Director and Student Trustees:

## 1. Report from the Director of Education.

Joan Carragher gave the Director's Report, which included the following points:

- In solidarity with those in Ukraine, there have been prayer services, masses, liturgies and fundraisers. A poignant video with recent images of the war and leaders united in hopes for peace in Ukraine was viewed.
- During the season of Lent there have been ongoing preparations for Easter and we look forward to the board-wide Faith Day on April 8<sup>th</sup>. "Building a Community that Accompanies" is the theme for this year and we look forward to welcoming Bishop Paul Andre Durocher who will be the keynote speaker.
- March 21, 2022, marked the first 'normal' return from March Break in two years and the lifting of mask mandates. It is estimated that on average across all of our schools 75 per cent of staff are choosing to continue to wear masks and approximately 35 percent of students continue to wear masks.
- The requirements of physical distancing and cohorting are no longer required and the vaccination mandates have been removed eliminating the need for unvaccinated staff to do weekly testing.
- There are several health measures still in place including the continuation of enhanced cleaning, hand sanitizing and respiratory etiquette and daily reporting of absences and the placement of additional hepa units provided by the Ministry of Education.
- Schools will maintain stock of masks, gloves, and sanitizer, however it is

expected that the use of PPE will drop significantly. The board, through the Ministry of Education, will continue provide PPE and RATs as needed.

- The provision by the Ministry of Education of free menstrual products that was announced last year are being received at the schools this week.
- The Learning Recovery Action plan includes tutoring opportunities that will be available from April to July.
- The modernization of elementary science and destreamed secondary curriculum has been received and will be implemented in September 2022 and supports will be forthcoming to assist elementary and secondary teachers as they implement the new guidelines.
- A letter has been received from the Terry Fox Foundation noting four PVNCCDSB schools in the top 50 school fundraisers. Congratulations to St. Peter Catholic Secondary School who placed second overall in Ontario, and to Holy Trinity Catholic Secondary School who placed fourth. St. Mary Catholic Secondary School and Holy Cross Catholic Secondary School also placed 10<sup>th</sup> and 16<sup>th</sup>, respectively. Together, these schools raised \$76,311.
- Thank you to all of our schools who participated in fundraising for the Terry Fox Foundation and this very important cancer research.
- Finally this time of year begins the plans for next year including budget planning, board improvement planning and alignment with strategic priorities, staffing and administration recruitment.
- Thank you to all staff and students for flexibility, perseverance and resiliency as we continue to work through the challenges of the pandemic.

Following her report, Joan Carragher invited questions and comments from the trustees.

## 2. Report from the Student Trustee, Siobhan Marie.

Student Trustee Siobhan Marie gave the Student Trustee report which included the following highlights:

- Student returned this week after a much-enjoyed March Break.
- There have been many student-led activities this month at all of our secondary schools.
- St. Peter Catholic Secondary School held a Pancake Tuesday event providing breakfast to students.
- Many schools held events raising funds for the Red Cross campaign such as wearing yellow and blue in support of Ukraine.
- A display with artefacts in the main foyer at St. Peter Catholic Secondary

celebrated 170 years in Catholic Education

- Holy Cross Catholic Secondary continue with healthy mindfulness quotes on the announcements and recently raised awareness for Down Syndrome with "Rock Your Socks Day". Their council is getting ready for their annual live-streamed "Holy Cross Game Show".
- St. Stephen Catholic Secondary continue to have family pizza days with Dominio's. The school has also continued to celebrate St. Stephen Royals of the month, where students are recognized for exemplary leadership and service in their school communities.
- International Women's Day was celebrated at St. Stephen with students wearing purple at school.
- Positive and uplifting messages were written on sticky notes and posted on Grade Nine lockers at Holy Trinity Catholic Secondary School by Link Crew members.
- St. Thomas Aquinas Catholic Secondary School celebrated Ash Wednesday mass in person for the first time since the beginning of the pandemic. The school is holding a food drive for the duration of Lent.
- A project to purchase Indigenous Literature for St. Thomas Catholic Secondary School has been undertaken with a \$750 grant from the Rising Youth Foundation. The goal of the project is to educate and challenge students to be aware of misconceptions or stereotypes they hold about Indigenous literature and culture. The goal is to expand the program to all schools of the Board.
- This month at the Student Council Leadership Committee, held this afternoon, Manager of Information Technology, Sean Heuchert shared the student technology survey with the committee members.

Siobhan Marie invited questions and comments at the conclusion of her report.

## 3. Report from the Manager of Communications.

The Manager of Communications, Galen Eagle gave a presentation on the composition and communications plan for the newly developed staff recognition program that will launch at the end of March. The program entitled "Everyday Hero" was formed with the importance of being valued in a learning community in mind.

The objective of the program will be to feature two employees each week from April to June this year who are nominated through an online form as an everyday hero. The recognized employees will receive recognition and swag that is branded with the initiative's logo. There are plans to evaluate the program and measure social media reach to determine if the program has added value and met the goals intended.

At the conclusion of his report, Galen Eagle invited questions and comments from the

trustees.

## C. Presentations:

## 1. Board Strategic Priority - Ensuring Equity: Board Update on Equity Initiatives.

Superintendent of Learning Jeannie Armstrong introduced Board Equity Advisory Mante Molepo who gave a slide show presentation to update trustees on the Equity Initiatives being undertaken at PVNCCDSB.

Mante Molepo reviewed the work that she has guided in the past year which has included review of policies and administrative procedures relating to equity and inclusive education, purchase of resources reflecting diversity, anti-black racism consultations, and professional development in the areas of leadership, anti-racism and anti-black racism. Professional development was also delivered with respect to Black History Month, which has included furthering education about changes to narratives throughout the year, beyond February. In addition, supports to educators and administrators on racism, equity, and inclusive education, supports to parent, in person visits to schools were also noted.

Following the presentation, Mante Molepo answered questions from the trustees.

## 2. Ensuring Equity: Student Census Data.

Jeannie Armstrong, introduced Learning Consultants Peter Bagnall and Sandra Connolly who gave a presentation on the collection and interpretation of the data from the recent student census and student synod discussions.

The data will help to shape the ways in which curriculum is delivered to students, identify ways to eliminate barriers to equitable education, and shape the board's pastoral plan.

The next steps with regard to student data collection are to communicate the results, use the data for equity planning and identify improvement areas. The next data collection will take place in the fall of 2022.

At the conclusion of the presentation, the presenters answered questions from the Trustees.

Dear Jonathan,

Please accept this letter in support of the proposed Holy Cross student trip to Guatemala March 22nd to April 1<sup>st</sup>, 2023.

Holy Cross has a history of very powerful life- changing mission trips to both Honduras and Guatemala – 14 in total. These sweat equity trips in solidarity with Guatemalans allow the students to experience firsthand what day to day life is like in a third world country. Working with the community, the students help to build a house for a single mother and her children. They also help with small projects in the mountains.

Wells of Hope, a Canadian organization, has been working in Guatemala since 2004. Once again, students will be working with Wells of Hope to make a difference in small communities. They will also experience cultural events, a Sunday Spanish mass, and visit an orphanage that Wells of Hope has helped to support.

## Guatemala March 22- April 1, 2023

## **Objectives:**

The objective of this excursion is for our students to implement their learned values and skills around Catholic Social Justice Teachings in a developing country. This is also an awareness trip for our students. They will learn the culture and values of the people of Guatemala and also work side by side with them, helping them to improve their living conditions in their community.

We believe this is a wonderful opportunity for our students to have this experience, and we feel it will strengthen our relationship with the greater Peterborough community. Our students are expected to be involved in raising funds locally to support the project down in Guatemala. This will help them to get a better perspective on the local issues around poverty and homelessness, then expand into the global issues, through Guatemala.

## History:

This will be Holy Cross SS 5<sup>th</sup> year in Guatemala, through Wells of Hope. Previously Holy Cross did 10 years of mission trips to Hondouras. Wells of Hope is a non-profit, charitable, independent, inter-denominational organization founded by Ted and Miriam Van der Zalm. Their main purpose is to bring clean water to the poor in Guatemala and assist them with educational and medical help when possible. Their operating principles are rooted in solidarity with their Guatemalan friends and our Christian beliefs. Wells of Hope is managed by a board of directors in the Niagara Region and has been working in Guatemala since 2004.

## Staff Attending:

Chris Clarke: Chris will be the lead teacher for this trip. He has been a Guidance Counsellor for the past 9 years and Teacher for the past 29 years. Over the past 29 years he has been involved in many **extracurricular** activities including many trips (including flying) involving OFSAA championships (Kenora, Ottawa, Windsor, etc.) and school trips to Ottawa, Spain and Greece. Chris has personally travelled throughout Europe, U.S. and Canada with his family. Chris organized the last four Mission Trips with Holy Cross to Guatemala. Christine Clarke: Teacher for the past 32 years. Over the past 32 years Christine has also been involved in many **extracurricular** activities including organizing many school trips throughout Canada, Spain and Greece. Christine has been involved organizing and participating in 2 of the Guatemala Mission Trips.

Julia Taylor: Teacher for the past 28 years. Julia has organized many trips to Honduras through Friends of Honduran Children. She also organized a Holy Cross school trip to South Africa. She has a good working knowledge of the Spanish language. Julia is trained in FIRST AID.

## Cost of the trip:

The cost is \$2550. This includes everyone's flights, accommodation and meals, supply coverage, transportation.

This trip only requires a travel agent to book flights, arrange insurance, book one hotel night and arrange transportation to and from the airport. Considering that we are one year from making this trip it is not possible to secure accurate flight information. The estimated cost of the flights is estimated on the previous 5 years of travel experience to Guatemala, current flight prices plus an additional 20% for unexpected concerns. The following three travel agents (listed below) have been contacted to look for best pricing for a flight. Given the outcome of these travel agents, a decision will be made on the best deal given the parameters of the trip, such as arrival and departure times as well as connection flights through a safe country (such as the US).

Accommodations: Wells of Hope is a non-profit organization that operates and owns Camp Esperanza in Jalapa, Guatemala and will provide all accommodations, food, travel and experience during our mission trip. Wells of Hope charges \$125 per day, per student/teacher to cover all costs while in Guatemala. The camp has a security guard and is in a safe location.

## Sharing Arrangements:

The "camp" Esperanza (Hope) is located about 4 km from the town of Jalapa in the state of Jalapa. This is where the group sleeps and eats their meals. The camp has the luxury of flush toilets and showering facilities. Sleeping accommodations are typically shared by up to 3 people. The camp has a security guard and is in a safe location.

## Swim Test:

During this trip there may be a possibility where students will cool off in a shallow small lake. A swim test will be held February 23, 2023 to ensure all **participants** meet the requirement for this activity.

## Supervision Ratio:

This trip is open to approx. 12 students (no more than 15) with 3 supervisors. The ratio is 1 teacher to 4 or 5 students

## Insurance Coverage:

The cost includes insurance coverage, which includes coverage if the Board decides that the trip cannot go or continue.

## <u>Medical coverage</u>

We also include, in the flight package, a deluxe insurance package which includes medical coverage.

## Rationale for the trip.

The trip will be an opportunity for the students to explore and experience a variety of educational opportunities.



## Historical and Educational:

- Students will have the opportunity to immerse themselves in the Italian culture, Catholic religious sites and historical sites.
- We will attempt to visit a Canadian Commonwealth War cemetery to honour Canadians who fought in Italy during World War II.
- They will travel with a licensed tour guide to a variety of historic locations including: Venice – St. Mark's Square, St. Mark's Basilica, and Doge's Palace; Verona – Romeo and Juliet balcony and Verona Arena; Florence – Ponte Vecchio and Duomo; Assisi – St. Francis of Assisi Basilica; Rome – Trevi Fountain, Vatican, Sistine Chapel and St. Peter's Basilica; Pompeli – guided tour of the site.
- From a religious, cultural and historical perspectives the students will be able to visit sites that fit into all the religion courses, Grade 10 History, Grade 11 Travel and Tourism and ancient history courses. This is great chance for them to truly see the past.

## Venice:

- Glass Blowing demonstration
  - Venice is famous for its ornate glass-work, known as Venetian glass. It is worldrenowned for being colourful, elaborate, and skilfully made.
  - o Art, Science
- St. Mark's Basilica
  - The Patriarchal Cathedral Basilica of Saint Mark (officially known in Italian as the Basilica Cattedrale Patriarcale di San Marco and commonly known as Saint Mark's Basilica) is the cathedral church of the Roman Catholic Archdiocese of Venice. It is the most famous of the city's churches and one of the best known examples of Byzantine architecture. It contains relics of St. Mark.
  - o Religion, Art, History
- Doge's Palace
  - The Doge's Palace (Italian: Palazzo Ducale) is a palace built in the Venetian Gothic style, and one of the main landmarks of the city of Venice. The palace was the residence of the Doge of Venice, the supreme authority of the Republic of Venice and opened as a museum in 1923.

## Verona

- Roman Amphitheatre
  - The Arena found in the city's largest piazza, the Piazza Bra. Completed around 30 AD, it is the third largest in Italy after Rome's Colosseum and the arena at Capua. It measures 139 metres long and 110 metres wide, and could seat some 25,000 spectators in its 44 tiers of marble seats.
  - o History, Art
  - Juliet's Balcony
    - A house claiming to be the Capulets' has been turned into a tourist attraction. It features the balcony, and in the small courtyard, a bronze statue of Juliet. It is one of the most visited sites in the town.

## Florence – capital of Tuscany:

- The Basilica di Santa Maria del Fiore (The Duomo Cathedral)
  - The cathedral complex, located in Piazza del Duomo, includes the Baptistery and Giotto's Campanile. The three buildings are part of the UNESCO World Heritage Site covering the historic centre of Florence. The Basilica is one of Italy's largest churches, and until the modern era, the dome was the largest in the world. It remains the largest brick dome ever constructed.
  - o Religion, History, Art
- Piazza della Signoria
  - An L-shaped square in front of the Palazzo Vecchio. It was named after the Palazzo della Signoria, also called Palazzo Vecchio. It is the focal point of the origin and of the history of the Florentine Republic and still maintains its reputation as the political hub of the city.
  - History, Civics
- The Ponte Vecchio
  - This is a medieval bridge over the Arno River which is famous for still having shops built along it. Butchers initially occupied the shops; the present tenants are jewellers, art dealers and souvenir sellers. It has been described as Europe's oldest wholly stone, closed-spandrel segmental arch bridge.

## Assisi

- The Basilica and Tomb of St. Francis
  - The Papal Basilica of St. Francis of Assisi (Italian: Basilica Papale di San Francesco) is the mother church of the Roman Catholic Order of Friars Minor commonly known as the Franciscan Order—in Assisi, Italy. The basilica is one of the most important places of Christian pilgrimage in Italy. With its accompanying friary, the basilica is a distinctive landmark to those approaching Assisi. It has been a UNESCO World Heritage Site since 2000.

Rome & Vatican:

- St. Peter's Basilica
  - St. Peter's Basilica is regarded as one of the holiest Catholic sites. The basilica is the burial site of its namesake Saint Peter, who was one of the twelve apostles of Jesus and, according to tradition, the first Bishop of Rome and therefore first in the line of the papal succession.
  - o Religion, Art, Science
- Sistine Chapel
  - This best-known chapel in the Apostolic Palace is the official residence of the Pope in Vatican City. It is famous for its architecture and its decoration that was frescoed throughout by Renaissance artists including Michelangelo, Sandro Botticelli, Pietro Perugino, Pinturicchio and others. Under the patronage of Pope Julius II, Michelangelo painted 1,100 m<sup>2</sup> of the chapel celling between 1508 and 1512. The ceiling, and especially *The Last Judgement* (1535–1541) and *The Creation of Adam* are believed to be Michelangelo's crowning achievement in painting.
  - o Religion, Art
- Colosseum
  - An elliptical amphitheatre in the centre of the city of Rome, the largest building ever built in the Roman Empire. It is considered one of the greatest works of Roman architecture and engineering. Capable of seating 50,000 spectators, the Colosseum was used for gladiatorial contests and public spectacles such as mock sea battles, animal hunts, executions, re-enactments of famous battles, and dramas based on Classical mythology. The building ceased to be used for entertainment in the early medieval era. It was later reused for such purposes as housing, workshops, and quarters for a religious order, a fortress, a quarry, and a Christian shrine.
  - o History, Science, Religion, Art
- Roman Forum
  - o This is a small, rectangular forum (plaza) surrounded by the ruins of ancient government buildings at the center of the city of Rome. Citizens of the ancient city referred to this marketplace as the Forum Magnum, or simply the Forum. Here statues and monuments commemorated the city's great men. The teeming heart of ancient Rome, it has been called the most celebrated meeting place in the world. Located in the small valley between the Palatine and Capitoline Hills, the Forum today is a sprawling ruin of architectural fragments and intermittent archaeological excavations.

## Pompeii:

- Guided tour of Pompeii
  - Pompeli is an ancient Roman city near modern Naples. Pompeli, along with Herculaneum was buried under volcanic ash and pumice in the eruption of Mount Vesuvius in AD 79.
  - It is part of a larger Vesuvius National Park and was declared a World Heritage Site by UNESCO in 1997.
