

At the Board Meeting held via videoconference on Tuesday, April 28, 2020 at 6:30 p.m., the Trustees:

APPROVED:

• That the board consider implementing a bell time change for St. Joseph CES, Bowmanville from the current bell time of 8:30 a.m.-2:55 p.m. to a new bell time of 9:20 a.m.-3:45 p.m., effective the 2021-2022 school year, in order to accommodate planned changes and enhancements to the transportation network serving the school. Administration is directed to coordinate communication of this change with STSCO and the school principal, and to ensure the school community be informed that a comment period (regarding this change and the postponement to 2021) continue to be open to parents until Sept. 30, 2020.

HEARD:

- A presentation about environmental initiatives in PVNC facilities by Superintendent of Business and Finance Isabel Grace and Facility Services Manager Richard Driscoll. The presentation offered Trustees a look at the efforts facility services has made over the past years to make environmental considerations and energy conservation a priority at Board facilities. Examples include environmentally friendlier roofing options, automated boiler and temperature controls in schools and automated cleaning dispensers that reduce waste.
- A detailed presentation about the implementation of the Board's Learn@Home plan for distance learning by Director of Education Michael Nasello and superintendents Laurie Corrigan, Pepe Garieri and Stephen O'Sullivan.
