At the Board Meeting held via videoconference on Tuesday, June 23, 2020 at 6:30 p.m., the Trustees:

RECOGNIZED:

• Outgoing senior student trustee Eveline Fisher of Holy Cross CSS for serving two years on the Board and advocating passionately and effectively for her peers at the Board and provincial level.

HEARD:

- Director of Education Michael Nasello updated trustees on the current stage of continuity of learning and school re-opening planning for September.
- Superintendent of Learning Tim Moloney and First Nations Métis Inuit learning consultant Sharon Lajoie provided an update to the Board's approved Experiences Canada student exchange between St. Peter CSS and a school community in Haida Gwaii, BC, a trip which was cancelled due to COVID-19 this year. Experiences Canada plans to run the exchange in the 2021 school year if it is safe to do so.
- Superintendent of Learning Tim Moloney and Superintendent of Special Education Laurie Corrigan provided an overview of the Board's Summer Learning Programs.
