



Notice of Passage of EDC By-Laws
City and County of Peterborough

On March 22, 2022, the Peterborough Victoria Northumberland and Clarington Catholic District School Board (“PVNCC”) passed the Peterborough Victoria Northumberland and Clarington Catholic District School Board 2022 Education Development Charges By-Law (County and City of Peterborough). No number was given to this By-law.

On March 29, 2022 the Kawartha Pine Ridge District School Board (“KPR”) passed the Kawartha Pine Ridge District School Board 2022 Education Development Charges By-Law (County and City of Peterborough) as By-law BL-22-001.

Under s. 257.65 of the *Education Act*, any person or organization may appeal either or both of the By-Laws to the Ontario Land Tribunal by filing with the secretary of the appropriate School Board a Notice of Appeal setting out the objection to that School Board’s By-law and the reasons supporting the objection. The last day for appealing the PVNCC By-law is May 2, 2022. The last day for appealing the KPR By-law is May 9, 2022.

The Education Development Charges imposed by the By-laws as of April 4, 2022 are set out in the following table:
